Whereas, the Ministry of Health & Family Welfare, Government of India vide its letter dated 15.06.2015 disapproved the renewal of permission for admission of 3rd batch of MBBS students against increased intake from 100 to 150 at Himalyan Institue of Medical Sciences, Dehradun for the academic year 2015-16 on the basis of recommendation made by Medical Council of India under the provisions of IMC Act, 1956 and Regulations made thereunder.

- And whereas, aggrieved by the decision of disapproval of the scheme by this Ministry, WP. No.6778 of 2015/LPA No. 589/2015 was filed by the Institute in the Delhi High Court. The Hon'ble High Court vide its order dated 21.09.2015 has quashed the Ministry's letter dated 15.06.2015 and directed the Union of India to forthwith consider the application of the Institute for renewal of permission for increased intake from 100 to 150 for the academic year 2015-16 keeping in view the assessment report of MCI dated 22.05.2015.
- Now therefore, in compliance of the direction of Hon'ble High Court, the Ministry has 3. considered the assessment report dated 22.05.20105 and decided to permit the Himalyan Institue of Medical Sciences, Dehradun to conduct the MBBS course against the increased intake from 100 to 150 (3rd Batch) for the acadmic year 2015-16, subject to following terms and conditions:
  - This permission is valid for one year and for admitting only one batch of 150 MBBS (i) seats during the academic year 2015-16. Admission in next batch of students for the year 2016-17 will be made only after renewal permission of the Central Government.
- Admissions made in violation of the above conditions will be treated as irregular and ે(ii) shall be liable for action under IMC Act, 1956 & Regulations made thereunder.
