7.	Minutes of the Meeting	The Secretary records the minutes, which are signed by the Chairperson and Secretary. A signed copy is forwarded to members within three (3) working days of the meeting

Duties and function	<ul style="list-style-type: none"> a) Plan and manage gender sensitization programs for students and staff, aligned with SRHU's anti-discrimination policies. b) Coordinate student-led forums and campaigns on gender rights, accessibility, and inclusive practices. c) Collaborate with faculty to reinforce classroom learning through club-based activities and experiential projects. d) Support grievance redressal awareness by promoting ICC mechanisms and safe reporting channels.
