1. While reporting for admission, the candidate shall bring all the relevant certificates/documents IN ORIGINAL as per **Annexure – 1** along with 2 sets of self attested copies of the same.
2. Tuition fee for first year must be deposited in full at the time of admission either by multi-city cheque of State Bank of India drawn in favour of Swami Rama Himalayan University or Bank Draft of any nationalized bank drawn in favour of Swami Rama Himalayan University, payable at Rishikesh/Dehradun. However, fee in the second year & third year of the course may be deposited in two equal instalments.
3. As per the orders passed by the Apex Court from time-to-time, the candidate is required to furnish either cash security or bank guarantee for the fee payable for the remaining period of the course.

Therefore, all candidates who obtain admission at Himalayan Institute of Medical Sciences shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course

OR

Post dated cheque in favour of Swami Rama Himalayan University for the balance unpaid tuition fee.

The bank guarantee/cheques shall be encashed by the University in case the candidate

leaves the course mid stream, after the last date of admission.
