1st Round (Reporting Time : 8:30 am)

1. Those candidates who have been allotted a seat during 1st Counseling held on 29th & 30th September & 1st October 2020 and are interested in changing the opted seat subject to availability of seats.

2nd Round (Reporting Time : 9:30 am)

2. Those candidates who have registered themselves for the first counseling held on 29th & 30th September & 1st October 2020 but could not attend it and are interested in seeking admission in Paramedical courses subject to availability of seats.

3rd Round (Reporting Time : 11:00 am)

3. Those candidates who have registered themselves to seek admission in other constituent colleges of SRHU but now interested in taking admission in Paramedical courses subject to availability of seats.

Uttarakhand & All India seats will be confirmed & allotted only after submission of Original Domicile & Caste Certificate (if applicable) at the time of physical verification. Those who

do not submit Domicile & Caste original documents, shall have no claim for Uttarakhand Seat.

After documents verification, you shall have to pay a **minimum 50% of Tuition fee along with other fees** (Admission, Security, Hostel, Examination, Student Activity Fee, Vaccination Charges etc. as mentioned in allotment letter), on the day of physical verification or latest by **24th October, 2020** in order to secure admission and issuing of Admission Order. The fee can be deposited either by **CASH OR** multi-city cheque / bank draft drawn in favour of Swami Rama Himalayan University payable at State Bank of India, HIHT, Jollygrant **OR** through RTGS/NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.
