With reference of your letter No. SRHU/Reg./Ext./2014-275 dated 31.10.2014 on the above subject, I am directed to inform you that Swami Rama Himalayan University, Swami Rama Nagar, Doiwala, Dehradun - 248140, Uttarakhand has been established by an Act No. 12 of 2013 and Notification No. 101/12/xxiv(6)2013 dated 12.03.2013 of State Legislature of Uttarakhand as a Private University and is empowered to award degrees as specified under Section 22 of the UGC Act through its main campus at regular mode with the approval of Statutory Bodies/Councils, wherever its required.

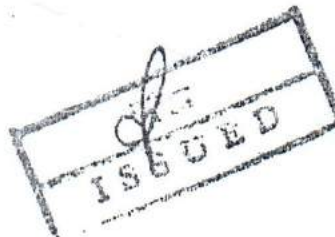
Swami Rama Himalayan University, Swami Rama Nagar, Doiwala, Dehradun - 248140, Uttarakhand is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yashpal Vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not granted any approval to the University to open off campus/study centre.
