Notice for Admission into PG Medical (MD/MS) courses at Himalayan Institute of Medical Sciences against seats allotted through First Common Counselling conducted by State Counseling Agency (Hemwati Nandan Bahuguna Uttarakhand Medical Education University) for academic session 2020-2021

All allotted candidates are advised to go through the notice [dated 20.04.2020](#) for admission which is available at the University Website: www.srhu.edu.in.

On account of lockdown due to COVID 19 pandemic, candidates who have been allotted seats through First Common Counseling conducted by the State Agency, i.e. Hemwati Nandan Bahuguna Uttarakhand Medical Education University (HNBUMU), Dehradun for admission into Postgraduate Medical (MD/MS) course at Himalayan Institute of Medical Sciences (HIMS), a constituent college of Swami Rama Himalayan University (SRHU), for academic session 2020-2021 are exempted from physical reporting at HIMS for seeking admission.
