Schedule of Counseling

SECOND COUNSELING - 1st ROUND (Reporting time : 8:30 A.M.)

1. Only those candidates are eligible who have been allotted a seat through 1st counseling of BSc Nursing held on **21st and 22nd October 2021** and are **interested in changing the opted seat to from All India Category to Uttarakhand Category** based on the merit subject to availability of seat(s).
2. Only those candidates are eligible who have **registered themselves for the first counseling held on 21st and 22nd October 2021 but have not been allotted any seat through 1st Counseling and are interested in seeking admission in BSc Nursing programme** based on the merit subject to availability of seat(s).

SECOND COUNSELING – 2nd ROUND (Reporting time : 10:00 A.M.)

3. Only those candidates are eligible who could not attend the first counseling held on **21st and 22nd October 2021** and are **interested to take admission into BSc Nursing programme, based on the merit** subject to availability of seat(s).
4. Candidates shall report for registration at the above mentioned time and schedule on the day of counseling as per their rank order. Candidates shall register themselves for allotment of seats. Mere registration by a candidate shall not guarantee allotment of seat.
5. Seat will be allotted to a candidate on the basis of merit prepared by the University and subject to his/her meeting the eligibility criteria.

Note:

- (a) The candidates who have been allotted seat/admitted provisionally and want to change seat, do not have to register themselves but have to appear personally on 23rd December 2021 at 8:30 a.m. **The candidates who are already provisionally admitted should bring their Admission Order / Allotment Letter alongwith fee receipt in original.** In the event of changing the seat, the candidate has to pay the fee as applicable to the changed programme /course on 23rd December 2021.
- (b) If a candidate, who has registered himself/herself on the first counseling held on **21st and 22nd October 2021** but has not been allotted any seat in the first counseling, is unable to appear in person on the notified date, he/she can send an authorized representative with an authority and undertaking letter alongwith requisite original documents and one set of self-attested photocopy of the same. The allotment made to the authorized representative shall be binding on such a candidate. If the candidate or his/her representative does not appear for counseling, it will be presumed that the candidate is not interested in taking the admission.

III) DOCUMENTS REQUIRED:

Registered candidates shall remain present in person with all the following documents in original, alongwith one set of attested photocopy of the same.

1.	High School (10 th Class) or equivalent examination's mark sheet
2.	High School (10 th Class) or equivalent examination's Certificate as proof of date of birth
3.	Mark sheet of Intermediate or qualifying examination (12 th Class) from a recognized Board.
4.	Pass certificate of Intermediate or qualifying examination (12 th Class) from a recognized Board.
5.	Recent Character Certificate from the School/College last attended/Gazetted Officer
6.	Transfer certificate/School leaving Certificate
7.	Migration Certificate (If Applicable)
8.	Aadhaar Card
9.	Caste or category (SC/ST/OBC) and (or) sub-category (FF, DPW, PH) certificate issued by competent authority (If Applicable). <i>Note: Candidates belonging to OBC category must produce their LATEST category certificate which should be valid on the day of counseling/admission</i>
10.	Permanent Residence Certificate for Utrakhand Candidate (If Applicable)
11.	Four passport size recent Colored Photographs
12.	Gap Year Affidavit (if applicable)
13.	Authority letter and Undertaking regarding authorization (if applicable) to be downloaded from the University website www.srhu.edu.in
14.	One set of photocopy of all the original documents.
15.	Bank Guarantee/Post dated Cheque for the remaining tuition fee of the course
16.	Guarantee bond (Annexure-1)

In case a candidate is unable to appear in person on the notified date, he/she can send an authorized representative with an authority and undertaking letter alongwith requisite original documents and one set of self-attested photocopy of the same. The allotment made to the authorized representative shall be binding on such a candidate. If the candidate or his/her representative do not appear for counseling, it will be presumed that the candidate is not interested in taking the admission.

Allotment:

After the Registration, allotment of seats will also be done on rank basis on the same day of counseling as per above mentioned schedule.

Fee & Mode of Payment of Fees:

Detail of Fee:

1. Fee structure for the above programs is prescribed in the Counseling Notification, information brochure and also on the university website – www.srhu.edu.in.
2. Candidates, who have been allotted the seat, are required to pay **half of the total fee** to secure admission **on the day of counseling i.e. on December 23, 2021**. The remaining fee can be submitted on the day of counseling or latest by December 27, 2021.
3. If any candidate fails to deposit the mentioned fee in Allotment Order, he/she shall have **NO CLAIM** whatsoever on the seat allotted through counseling.
4. Hostel shall be allotted only on deposition of requisite hostel fee.

Mode of Payment of Fees:

The fee can be deposited either by multi-city cheque / bank draft drawn in favour of 'Swami Rama Himalayan University' payable at State Bank of India, HIHT, Jollygrant.

OR

Through RTGS/NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

The candidates are required to submit a proof of RTGS/Net Banking payment made towards the fees in the office of the Himalayan College of Nursing immediately after payment is made through email (office.hcn@srhu.edu.in).

WITHDRAWAL OF ADMISSION & REFUND POLICY

After 27th December 2021, withdrawal from the programme will not be permissible. No fee will be refunded after the last date of admission as decided by the university

NOTE:

1. All allotments will be done strictly on rank basis subject to verification of original certificates/documents of the candidates. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding. If any candidate fails to appear in counseling in person or through an authorized representative or fails to produce original certificates or fails to pay fee within the prescribed time frame, he/she will not be entitled to claim for any seat in B.Sc. Nursing programme.
2. All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found at a later stage, during active verification, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
3. Before reporting to the college, candidates must take two doses of vaccination against COVID-19.
4. As per the orders passed by the Apex Court from time-to-time, the candidate is required to furnish either cash security or bank guarantee for the fee payable for the remaining period of the course.

Therefore, all candidates who obtain admission at Himalayan College of Nursing shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course

OR

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee of the entire duration of the course, as cash security.

The bank guarantee/cheques will be encashed by the University in case the candidate leaves the Programme mid-stream, after the admission.

Nursing course to Himalayan College of Nursing (HCN), a constituent college of Swami Rama Himalayan University (SRHU) “hereinafter referred to as University”, in favour of the Registrar, Swami Rama Himalayan University, Swami Ram Nagar, P.O. Jolly Grant, Dehradun.

Whereas, the student is qualified for admission in the Basic B.Sc. Nursing course to Himalayan College of Nursing (HCN), a constituent college of Swami Rama Himalayan University with the understanding and subject to the undertaking/Guarantee that the student shall undergo the course on regular full-time basis and shall maintain the required standard of performance.

Whereas, the student has read and understood the consequences of the orders of Hon’ble Supreme Court of India in the matter of Unnikrishnan J.P. & Others Versus State of Andhra Pradesh & Others in Writ Petition (Civil) No.607 of 1992 and Islamic Academy of Education and Another V/s State of Karnataka & Others in Writ Petition (Civil) No. 350 of 1993. In view of the Judgment of the Hon’ble Supreme Court of India the student undertakes to Guarantee the university with the payment of full/outstanding amount of fee in any of the following circumstances:-

- a. Where the student does not join the course on allotment of seat after the expiry of the last date of withdrawal.
- b. Where the student opts out of the course before its completion.
- c. Where the course is discontinued by the student owing to any unforeseen reasons or whatsoever.
- d. Where the admission of the student is cancelled/terminated by the university due to unsatisfactory performance, indiscipline and/or misconduct.
