Notice for Admission into Undergraduate Medical - MBBS Programme for Academic Session 2021-2022

- 1. It is hereby informed that for the academic session 2021-2022, admissions to Undergraduate Medical MBBS Programme conducted at **Himalayan Institute of Medical Sciences**, a constituent Medical College of the Swami Rama Himalayan University, (a University established under section 2(f) of UGC Act, 1956 & enacted vide Uttarakhand Act No. 12 of 2013) shall only be made based on the merit of NEET (UG)-2021 and through common counseling conducted by the State Government or its designated authority and none else.
- 2. Accordingly, on behalf of State of Uttarakhand, the Hemwati Nandan Bahuguna Uttarakhand Medical Education University, Dehradun shall be conducting common counseling for admission into Undergraduate Medical MBBS Programme for academic session 2021-2022 based on the merit of NEET (UG)-2021.
- 3. All NEET (UG)-2021 qualified candidates are invited to register for the process of common counselling & admission into **Himalayan Institute of Medical Sciences**. For registration process and other related details for common counseling, kindly visit the website www.hnbumu.ac.in
- 4. The **Himalayan Institute of Medical Sciences**, has permission from National Medical Commission, formerly known as Medical Council of India, to admit 150 candidates in MBBS Programme. As per the provisions of section 33(1) of the Swami Rama Himalayan University Act 40% seats (60 seats) are reserved for the permanent residents of Uttarakhand. Reservation policy of the State of Uttarakhand shall be applicable on these 60 (Sixty) seats.

5. Fee:

- 5.1 The Tuition Fee for MBBS Programme shall be Rs. 18,00,000/- (Rupees Eighteen Lakhs only) per annum.
- 5.2 As per the provisions of Section 33(2) of the Swami Rama Himalayan University Act, 26% rebate in tuition fee shall be applicable to 40% of 150 candidates (60 students) who are admitted under the "Permanent Resident of Uttarakhand" category. The rebate in tuition fee to such students will be given after the last date of admission and on completion of the admission process.

- 5.3 In addition to the tuition fee, a candidate shall be charged the following fees:
 - (i) One time Non Refundable Admission Fees of Rs. 1,00,000/- for all categories.
 - (ii) One time Refundable Security Fees of Rs. 2,00,000/- for all categories.
 - (iii) Hostel Fee for all categories Non-AC rooms shall be Rs. 90,000/- per annum on twin sharing basis and for AC rooms Rs. 1,20,000/- per annum on twin sharing basis.
 - (iv) Mess Charges as per actuals.
 - (v) Enrolment Fee (one time) for all categories: Rs. 1,000/-
 - (vi) Charges for hepatitis-B vaccination for all categories: Rs. 1,500/-
 - (vii) University Examination Fee shall be charged as per University rules as and when required.
 - (viii) Dress Material charges (one time) for all categories: Rs. 10,000/-
 - (ix) Convocation Charges (to be charged in the final year): Rs. 2,000/-
 - (x) Alumni Fee (to be charged in the final year): Rs. 1,000/-
- 5.4 Tuition fees can be deposited at the time of admission either by multi-city cheque/bank draft drawn in favour of Swami Rama Himalayan University or through RTGS directly to University Bank Account No. 33082676422, IFSC Code: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

5.5 Note:

- (i) The fees for First Professional shall continue to be charged till the candidate passes out the First Prof. Exam.
- (ii) The candidate must pass First Professional in 14 (fourteen) months; otherwise tuition fees shall be charged as follows:
 - (a) If a student fails or is detained in 01 (one) subject in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay 1/3 (one-third) amount of the existing tuition fee per annum as additional tuition fee till the student passes out First Professional Examination.
 - (b) If a student fails or is detained in 02 (two) subjects in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay 2/3 (two-third) amount of the existing tuition fee per annum as additional tuition fee till the student passes out First Professional examination.



- (c) If a student fails or is detained in all the subjects in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay full existing tuition fee as additional tuition fee per annum till the student passes out First Professional Examination.
- (d) Not more than four attempts shall be allowed for a candidate to pass the First Professional examination. The total period for successful completion of First Professional course shall not exceed 04 (four) years. Partial attendance of examination in any subject shall be counted as an attempt.
- (iii) After passing the First Professional Examination, every student must pass Second Professional, Final Professional Part I & Final Professional Part II in 42 (forty-two) months. If he/she fails to do so, he/she shall pay ½ (half) amount of the tuition fee determined by the University for Final Professional Part II as an additional tuition fee per annum till he/she passes Final Professional Part II University Examination.

A student shall not be entitled to graduate later than 10 (ten) years of his/her joining the first MBBS course.

(iv) As per the orders passed by the Hon'ble Apex Court from time-to-time, the candidate is required to furnish either cash security or bank guarantee for the fee payable for the remaining period of the programme.

Therefore, all candidates who obtain admission at Himalayan Institute of Medical Sciences shall be required to submit at the time of joining, either a bank guarantee for the balance unpaid tuition fee.

OR

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee.

The bank guarantee/cheques will be encashed by the University in case the candidate leaves the programme midstream, after the last date of admission.
