COUNSELLING SCHEDULE – 2022

Admission Process:

Eligible candidates shall report for registration at **10:00am** on Monday, **June 20, 2022**. Candidates are required to reach the counselling area atleast half an hour before the prescribed time

Allotment of Seats:

1. After the Registration, Merit list will be prepared on the basis of marks scored in the last qualifying examination followed by personal interview.
2. The Final Merit list will be displayed on the notice board at 12.00 p.m. on the same day.
3. Allotment of seats will be done through counseling from 12:30 pm onwards as per merit list.
4. Candidates, who have secured the rank in merit list, are required to remain present in person with the following documents in original alongwith one set of self attested photocopies of the same.

Relieving Letter, if employed

2. Mode of Payment:

- i) Candidates are required to pay **half of the total fee** to secure admission **on the day of counseling i.e. June 20, 2022**. The remaining fee can be submitted on or before June 27, 2022 failing which candidate shall have no claim on the allotted seat.
- ii) Fees can be deposited either by multi-city cheque / bank draft drawn in favour of Swami Rama Himalayan University or through RTGS / NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580
- iii) After submission of the fees mentioned in Allotment Order and physical verification of the documents from original documents, Admission Order can be obtained from Himalayan College of Nursing.

NOTE:

1. All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found during physical verification or at a later stage, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
2. All allotments are subject to the authenticity of facts from the verification of original certificates/documents of the candidates before receiving Admission Order from Himalayan College of Nursing. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding.
3. If the candidate leaves the program before September 30, 2022, the Admission Fee shall not be refunded. In case the candidate wants to discontinue the program after September 30, 2022 then he / she shall be required to deposit the fee for the entire duration of the program. M.Sc. Nursing and Post Basic B.Sc. Nursing programs will commence from October 1, 2022 and Nurse Practitioner in Critical Care - Post Graduate Residency Program will commence from November 1, 2022.
