### **4. Schedule of Second Counseling**

#### **1<sup>st</sup> ROUND (Reporting time : 8:30 A.M.)**

- a) Only those candidates are eligible who have been allotted a seat through 1<sup>st</sup> counseling of BSc Nursing held on **6<sup>th</sup> & 7<sup>th</sup> September 2022** and are **interested in changing the opted seat from All India Category to Uttarakhand Category** based on the merit and subject to availability of seat(s).

#### **2<sup>nd</sup> ROUND (Reporting time : 10:00 A.M.)**

- b) Only those candidates are eligible who have **registered themselves for the first counseling held on 6<sup>th</sup> & 7<sup>th</sup> September 2022 but have not been allotted any seat through 1<sup>st</sup> Counseling** and are **interested in seeking admission in BSc Nursing programme** based on the merit subject to availability of seat(s).

## **5. Registration & Admission Process**

1. Candidates shall report for registration at the above mentioned time and schedule on the day of counseling.
2. Candidates shall register themselves at Registration counter on day of counselling. Mere registration by a candidate shall not guarantee allotment of seat.
3. Registered candidates shall remain present in person with all required documents in original, alongwith one set of self-attested photocopy of the same. After the Registration, original documents will be verified by college authorities.
4. The candidates who have already been allotted seat/admitted provisionally and want to change seat, do not have to register themselves but have to appear personally on the day of counseling.
5. **The candidates who are already provisionally admitted should bring their Admission Order / Allotment Letter alongwith fee receipt in original.** In the event of changing the seat, the candidate has to pay the fee as applicable to the changed programme /course on the day of counseling.
6. Allotment of seats will be done on merit basis on the same day of counseling as per above mentioned schedule and subject to his/her meeting the eligibility criteria.
7. If a candidate, who has registered himself / herself on the first counseling held on **6<sup>th</sup> & 7<sup>th</sup> September 2022** but has not been allotted any seat during first counseling and is unable to appear in person on the notified date, he / she can send an authorized representative with an authority letter and undertaking alongwith requisite original documents and one set of self-attested photocopy of the same. The allotment made to the authorized representative shall be binding on such a candidate and shall not be considered for any change in any way whatsoever.
8. If any candidate fails to appear in counseling in person or through an authorized representative or fails to produce original certificates, he/she will not be entitled to claim any right on any seat in B.Sc. Nursing programme.
9. After the allotment of seat, in case any candidate fails to pay fee within the prescribed time, his/her candidature for admission into B.Sc. Nursing programme shall be outrightly rejected and such seat shall be allotted to the next eligible candidate in merit.

## **6. Detail of Fee & Mode of Payment**

### **Detail of Fee:**

1. Fee structure for the above programs is prescribed in the Counseling Notification, information brochure and also on the university website – [www.srhu.edu.in](http://www.srhu.edu.in).
2. Candidates, who have been allotted the seat, are required to pay **Rs.1,00,000/- (Rupees One Lakh Only)** to secure admission **on the day of counseling** failing which he/she shall have NO CLAIM whatsoever on the seat allotted through counseling.
3. Remaining fees must be deposited latest by **30<sup>th</sup> September 2022**.

### **Mode of Payment of Fees:**

The fee can be deposited either by multi-city cheque / bank draft drawn in favour of 'Swami Rama Himalayan University' payable at State Bank of India, HIHT, Jollygrant.

OR

Through RTGS/NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

The candidates are required to submit a proof of RTGS/Net Banking payment in the office of the Himalayan College of Nursing through email ([office.hcn@srhu.edu.in](mailto:office.hcn@srhu.edu.in)) immediately after payment is made towards the fees.

## **7. Withdrawal of Admission & Refund Policy**

The last date for the withdrawal of admission from B.Sc. Nursing programme shall be **30<sup>th</sup> September 2022**. In case any candidate wishes to withdraw after **30<sup>th</sup> September 2022**, no fee will be refunded to him/her.

### **NOTE:**

1. All allotments will be done strictly on merit basis, subject to verification of original certificates/documents of the candidates. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding.
2. All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found during physical verification or at a later stage, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
3. As per the orders passed by the Apex Court, the candidate is required to furnish either cash security or bank guarantee for the fee payable for the remaining period of the course.

Therefore, all candidates who obtain admission at Himalayan College of Nursing shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course

**OR**

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee of the entire duration of the course, as cash security.

The bank guarantee/cheques will be encashed by the University in case the candidate leaves the Programme mid-stream, after the admission.
