**Notification of Second Counseling for B.Sc. Nursing Programme - 2023**

Second counseling for admission into B.Sc. Nursing Programme will be held on **15<sup>th</sup> July 2023** in Swami Rama Himalayan University, Swami Ram Nagar, Jolly Grant, Dehradun, Uttarakhand.

**2. Schedule of Second Counseling**

**1<sup>st</sup> ROUND (Reporting Time : 8:30 A.M.) on 15<sup>th</sup> July 2023**

- a) Only those candidates are eligible who have been allotted a seat through 1<sup>st</sup> counseling of B.Sc. Nursing held on **3<sup>rd</sup> & 4<sup>th</sup> July 2023** and are **eligible to opt seat from All India Category to Permanent Residents of Uttarakhand seat** based on the merit and subject to availability of seat(s). Such candidates must bring their Admission Order / Allotment Letter alongwith fee receipt in original.

**2<sup>nd</sup> ROUND (Reporting Time : 10:00 A.M.) on 15<sup>th</sup> July 2023**

- b) Only those candidates are eligible who have **registered themselves for the first counseling held on 3<sup>rd</sup> & 4<sup>th</sup> July 2023 but have not been allotted any seat through 1<sup>st</sup> Counseling due to unavailability of seats and are interested** in seeking admission in B.Sc. Nursing programme based on the merit subject to availability of seat(s).

### **3. Registration & Admission Process**

1. Candidates shall report for the counseling at the above mentioned time and schedule.
2. Registered candidates shall remain present in person with all required documents in original, alongwith one set of self-attested photocopy of the same.
3. After the Registration, original documents will be verified by college authorities.
4. The candidates who have already been allotted seat/admitted provisionally and want to change seat, do not have to register themselves but have to appear personally on the day of counseling.
5. Allotment of seats will be done on merit basis on the same day of counseling as per above mentioned schedule and subject to his/her meeting the eligibility criteria.
6. If a candidate, who has registered himself / herself on the first counseling held on **3<sup>rd</sup> & 4<sup>th</sup> July 2023** but has not been allotted any seat during first counseling and is unable to appear in person on the notified date, he / she can send an authorized representative with an authority letter and undertaking alongwith requisite original documents and one set of self-attested photocopy of the same. The allotment made to the authorized representative shall be binding on such a candidate and shall not be considered for any change in any way whatsoever.
7. If any candidate fails to appear in second counseling in person or through an authorized representative or fails to produce original certificates, he/she will not be entitled to claim any right on any seat in B.Sc. Nursing programme.
8. After the allotment of seat, in case any candidate fails to pay fee within the prescribed time, his/her candidature for admission into B.Sc. Nursing programme shall be outrightly rejected and such seat shall be allotted to the next eligible candidate in merit.

## 6. Detail of Fee & Mode of Payment

### Detail of Fee & Mode of Payment

#### Detail of Fee:

1. Fee structure for the above programs is prescribed in the Counseling Notification, information brochure and also on the university website – [www.srhu.edu.in](http://www.srhu.edu.in).
2. Candidates, who have been allotted the seat, are required to pay **Rs.1,00,000/- (Rupees One Lakh Only)** to secure admission **on the day of counseling** failing which he/she shall have NO CLAIM whatsoever on the seat allotted through counseling.
3. Remaining amount of fees must be deposited on or before 19<sup>th</sup> July 2023.

#### Mode of Payment of Fees:

The fee can be deposited by Demand Draft drawn in favour of 'Swami Rama Himalayan University' payable at State Bank of India, HIHT, Jollygrant.

OR

Through RTGS / NEFT / Net Banking directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

The candidates are required to submit a proof of RTGS/NEFT/Net Banking payment in the office of the Himalayan College of Nursing through email ([office.hcn@srhu.edu.in](mailto:office.hcn@srhu.edu.in)) immediately after payment is made towards the fees.

## **7. Withdrawal of Admission & Refund Policy**

The last date for the withdrawal of admission from B.Sc. Nursing programme shall be **19<sup>th</sup> July 2023**. In case any candidate wishes to withdraw after **19<sup>th</sup> July 2023**, no fee will be refunded to him/her.

### **NOTE:**

1. All allotments will be done strictly on merit basis, subject to verification of original certificates/documents of the candidates. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding.
2. All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found during physical verification or at a later stage, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
3. As per the orders passed by the Apex Court, the candidate is required to furnish either bank guarantee or post-dated cheques for the fee payable for the remaining period of the course.

Therefore, all candidates who obtain admission at Himalayan College of Nursing shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course

**OR**

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee of the entire duration of the course, as cash security.

The bank guarantee/cheques will be encashed by the University in case the candidate leaves the Programme mid-stream, after the admission.

In view of the Judgment of the Hon’ble Supreme Court of India the student undertakes to Guarantee the university with the payment of full/outstanding amount of fee in any of the following circumstances:-

- a. Where the student does not join the course on allotment of seat after the expiry of the last date of withdrawal.
- b. Where the student opts out of the course before its completion.
- c. Where the course is discontinued by the student owing to any unforeseen reasons or whatsoever.
- d. Where the admission of the student is cancelled/terminated by the university due to unsatisfactory performance, indiscipline and/or misconduct.
