# SWAMI RAMA HIMALAYAN UNIVERSITY

## Policy for Private OPD within the Himalayan Hospital


1. This Policy shall be called 'Policy for starting of paid Private OPD within the Himalayan Hospital'.
2. This Policy shall come into force from the date of approval of the Board of Management of the University.
3. Subject to approval of the competent authority, the clinicians working in the Himalayan Institute of Medical Sciences will be allowed to work in paid OPDs in the University premises (at the main campus).
4. Clinicians selected by the University shall be granted permission to work in paid OPDs in the premises of the University on the following terms & conditions:-
  - i. Timings for Paid OPD shall be decided by the University in such a manner so that teaching and training of the students is not affected adversely.
  - ii. Infrastructure and human resource shall be provided by the University.
  - iii. Consultation charges shall be determined by the University.
  - iv. Consultation charges within the main premise of the University shall be shared between clinician and University in the ratio of 40:60.
  - v. The clinicians working in the paid OPD shall be governed by the code of conduct of the University.
  - vi. In case after following the due process malpractice is proved against the Clinician, the permission granted shall be withdrawn and disciplinary action shall be taken as per University norms.
5. The University reserves the right to interpret, alter, amend, modify, cancel or withdraw any of the provisions mentioned here-in-above without any notice.
6. In case of any dispute, decision of the Authorities of the University shall be final and binding.

## Policy for Private OPD outside University premises

1. This Policy shall be called 'Policy for allowing clinicians for Private OPD outside University premises'.
2. This Policy shall come into force from the date of approval of the Board of Management of the University.
3. No Private Personal OPDs shall be permitted.
4. Paid OPDs shall be permitted in centres developed and managed by the University outside the main campus or any town/cities.
5. Clinicians approved by the University shall be granted permission to work in paid OPDs in the centres of the University on the following terms & conditions:-
  - i. Timings for Paid OPD shall be decided by the University in such a manner so that teaching and training of the students is not affected adversely.
  - ii. Infrastructure and human resource shall be provided by the University.
  - iii. Consultation charges shall be determined by the University.
  - iv. Consultation charges shall be shared between clinician and University in the ratio of 40:60.
  - v. The clinicians working in the paid OPD shall be governed by the code of conduct of the University.
  - vi. In case after following the due process malpractice is proved against the Clinician, the permission granted shall be withdrawn and disciplinary action shall be taken as per University norms.
  - vii. Clinician who has been granted permission shall provide clinical services/consultation only beyond the working hours of the University or on holidays (when clinician is not on call) so that work of the University/Himalayan Institute of Medical Sciences (HIMS)/Himalayan Hospital (HH) does not suffer.
  - viii. The clinician shall not be permitted to admit any patient in the premises of any other hospital/nursing home/person or at his own premises. All admission shall only be done at the main hospital of the University/Centres of the University, if any, if they have provision for IPD facilities.
6. The University reserves the right to interpret, alter, amend, modify, cancel or withdraw any provision mentioned here-in-above without any notice.
7. Any violation of the terms and conditions shall be sufficient ground to withdraw the permission with immediate effect.
8. In case of any dispute, decision of the Authorities of the University shall be final and binding.
