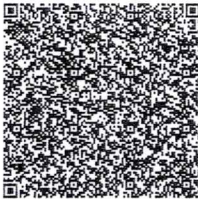



## TRUST DEED

This Deed of Trust (the "Trust Deed") is executed, on this ~~10<sup>th</sup>~~<sup>16<sup>th</sup></sup> day of May 2021 by **Swami Rama Himalayan University** (a University established by Uttarakhand Act No. 12 of 2013), situated at Swami Ram Nagar, P.O. Jolly Grant, Dehradun – 248016 hereinafter called as 'the Founder' of the Trust which expression shall, unless excluded by or repugnant to the context, be deemed to include its successors, authorized administrators and authorized representatives.

WHEREAS the Board of Governors of the Founder (Swami Rama Himalayan University) in its 24<sup>th</sup> meeting held on 31<sup>st</sup> March 2021 under item no. 05 (Five) has decided to create and establish a Trust by the name of **Swami Rama Himalayan University Alumni Association** to bring its all Alumni together under one forum for mutual benefit without discrimination of caste, creed, race, religion or sex and with objects and constitution as hereinafter set forth;

AND WHEREAS in the said meeting dated 31<sup>st</sup> March 2021 the Board of Governors of the Founder (Swami Rama Himalayan University) unanimously decided to authorize

Dr. Vijay Dhasmana, Vice Chancellor of the Founder, to sign and execute this Trust Deed on behalf of the Founder i.e. Swami Rama Himalayan University;

AND WHEREAS to start the Trust the Founder (Swami Rama Himalayan University) hereby conveys, transfers and grants unto the trust a sum of Rs. 1,00,000/- (Rupees One Lakh) only. This initial amount shall form the initial corpus of the Trust and to be used and appropriated by the Governing body of the Trust in order to carry out and fulfil the objectives of the Trust;

AND WHEREAS it has therefore been thought expedient to reduce the terms to writing.





NOW THIS DEED WITNESSETH AS UNDER:

**1. NAME**

The name of the Trust shall be “**Swami Rama Himalayan University Alumni Association**” hereinafter also referred as Trust (Alumni Association).

**2. REGISTERED OFFICE**

The Registered office of the Trust (Alumni Association) shall be at “**Swami Ram Nagar, P.O. Jolly Grant, Dehradun, Uttarakhand, India**” and at such other place or places as may be decided by the Governing Body of the Trust (Alumni Association) in consultation with the Founder.

**3. AREA OF WORKING**

Area of working of the Trust (Alumni Association) shall be whole of world where the Alumni of Swami Rama Himalayan University reside.


**4. INTERPRETATION**

- (i) Unless it is evident from the context and having regards to the generality of this Trust Deed that a clause intends to mean otherwise: words denoted in the singular shall include the plural and vice versa; words denoted in any gender shall include all genders; and, terms denoting people or persons shall include both natural and legal persons (such as corporations) and vice versa.
- (ii) The heading names in the Trust Deed are provided as reference only and do not form part of the Trust Deed.
- (iii) The Trust Deed or declarations may be executed in both English and other languages. If there is a conflict between this Trust Deed in its various translations the English version shall prevail.
- (iv) This Trust Deed may be executed either in one original or in counterpart.

**5. AIMS AND OBJECTIVES**

The Aims and Objectives of the Trust (Alumni Association) shall be:-

- (i) To provide a vibrant forum that promotes interaction, networking and friendly relations among Alumni of the University.

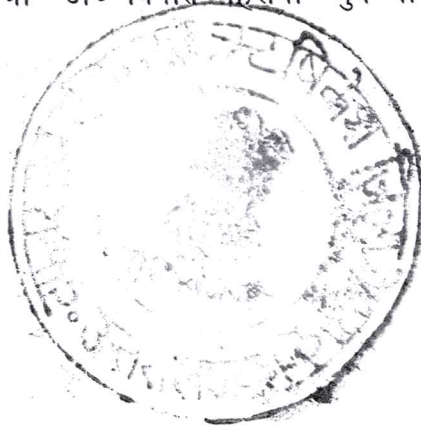

- (xi) To do all such lawful acts and things whether incidental to the powers aforesaid or not, as may be necessary to further the objects of the Trust.

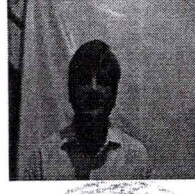
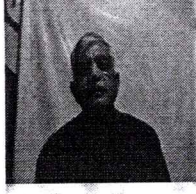
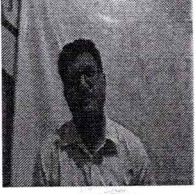
## 6. MEMBER



**6.2 ASSOCIATE MEMBERSHIP:** The following shall be eligible for Associate Membership of the Alumni Association.

- (i) All member of the teaching staff/faculty of the Founder, who are not Alumni of the Founder, working on regular basis.
- (ii) All ex-members of teaching staff of Founder, who have worked with the Founder or its academic units for minimum period of 2 (two) years.
- (iii) All associate members shall have participatory rights in conferences, seminars, workshops and discussions, be member of the sub-committees, can act as advisors and can be co-opted as members of various committees but shall have no voting rights.


## **7. MEMBERSHIP FEE**


The Membership Fee of the Life members shall be as decided by the Governing Body of the Trust (Alumni Association) from time to time.

## **8. CESSATION OF MEMBERSHIP**

The member of the Trust (Alumni Association) shall cease to be a member if:-

- (i) He dies, resigns, becomes unsound mind, becomes insolvent or he is convicted of a criminal offence.
- (ii) He is found to be involved in any anti-social, anti-Alumni, anti-alma mater, anti-India activity.
- (iii) He is found guilty by the Governing Body of anti-propagation of the working/activities of the Trust (Alumni Association) and his alma-mater.
- (iv) He is removed by the Governing Body for disregarding rules & regulations or the decisions of the Governing Body.

(v)  








## 9. GOVERNING BODY

9.1 For smooth functioning of the Trust (Alumni Association) and for carrying out the day to day administration and for achieving the aims and objects of the Trust (Alumni Association), Governing Body of Trust (Alumni Association) shall have:-

- (i) 01 (One) President;
- (ii) 01 (One) Vice President;
- (iii) 01 (One) General Secretary;
- (iv) 01 (One) Joint Secretary;
- (v) 01 (One) Treasurer; and
- (vi) 10 (Ten) Members


9.2 All the office bearers, i.e. The President, Vice-president, General Secretary, Joint Secretary and Treasurer of the Governing Body shall be nominated by the Founder for a period of 05 (five) years. However an office bearer shall be eligible for re-nomination of one more term.

9.3 Out of the 10 (Ten) members of the Governing Body, 04 (four) members shall be nominated by the Founder and remaining 06 (six) members shall be elected by the Alumni (Life members) from among themselves. The tenure of these 10 (Ten) members shall be for a period of 03 (three) years.

9.4 All the members of the Governing Body shall have equal right to vote.

9.5 The First Governing body shall be constituted by the Founder (Swami Rama Himalayan University). Tenure of the First Governing Body shall be for a period of 03 (three) years from the date of its constitution. After that the Governing shall be constituted as per provisions of clause 9.2 & 9.3 of this trust deed.

9.6 In case any vacancy arises in the Governing Body for whatsoever reason, the Founder shall fill it by nomination. A member so nominated shall continue as a member of the Governing Body only until the remaining term of the previous member in whose place he has been nominated.






## 10. ELECTION PROCESS

- (i) The election for the membership of the 06(six) Governing Body members shall be open to the life member. An alumnus of the Trust (Alumni Association) shall propose the name of an individual willing to contest the election for the membership of the Governing Body and duly seconded by another alumnus. The sitting elected members of the Governing Body shall be eligible for one more term only.
- (ii) Election for the membership of 06 (six) elected members of the Governing Body shall be held through secret ballot or electronic ballot.
- (iii) The detailed procedure of the elections shall be as per the rules made in this regard by the Governing Body.
- (iv) The election shall be conducted by an Election Commission of minimum 03 (three) members constituted by the Governing Body. The members of the election commission shall not be the members of the Trust (Alumni Association).
- (v) In case, the election for the membership of six elected members are not conducted due to any reasons whatsoever, then the existing members shall continue as a member of the Governing Body for next one year or till the new members are elected, whichever is earlier.
- (vi) In case, there is any dispute regarding election of any member to the Governing Body, the dispute shall be referred to the Founder. The Founder shall resolve the dispute in a manner as it deems fit. The decision of the Founder in this regard shall be final and binding.

## 11. POWERS OF GOVERNING BODY

To achieve the objectives of the Trust (Alumni Association), the Governing Body shall have the following powers:







- (i) To make rules for the efficient functioning and affairs of the Trust (Alumni Association).
- (ii) To purchase, take on lease, accept as a gift or otherwise acquire any land or building or other property, wherever situated in India, with prior approval of the Founder.
- (iii) To sell, lease, exchange and otherwise transfer, for consideration or otherwise, all or any portion of the properties, assets and liabilities of the Trust (Alumni Association) to any other society, trust or other individual person or persons or any other body, institution or organization etc., with prior approval of the Founder
- (iv) To invest and deal with any money of the Trust (Alumni Association) which may not be immediately required for the purpose thereof in such Government Securities, deposits in Banks and in such a manner as the Governing Body may deem fit, with prior approval of the Founder,
- (v) To open/close accounts of the Trust (Alumni Association) and to appoint/remove signatories.
- (vi) To accept donations.
- (vii) To appoint auditors for the Trust (Alumni Association).
- (viii) To borrow money on the security of the properties of the Trust (Alumni Association) with prior approval of the Founder.
- (ix) To make arrangements for conducting seminars, workshops, conferences, meets etc. for the Alumni of Trust (Alumni Association).
- (x) To prepare the annual budget of the Trust (Alumni Association) with the help of a Chartered Accountant and to fix limits of total annual recurring and non-recurring expenditure based on the income and resources of the Trust (Alumni Association) and to submit it before the Founder for its approval.






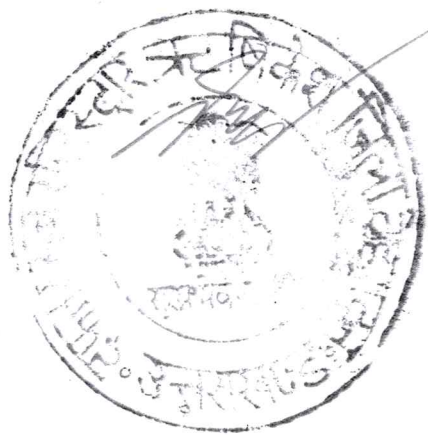
- (xi) To appoint any such staff as may be necessary for the administration and functioning of the Trust (Alumni Association) either on contract basis or otherwise, with prior approval of the Founder.
- (xii) To determine the salary and wages of the staff employed in the Trust (Alumni Association) with prior approval of the Founder.
- (xiii) To redress any grievances of the Alumni and employees of the Trust (Alumni Association).
- (xiv) To authorize any office bearer or Governing Body member of the Trust (Alumni Association) to sign agreements, contracts or any other legal documents with the Governments or Institutions or Organizations or bodies in connection with the receiving of grants and administering the affairs of the Trust (Alumni Association).
- (xv) To submit the annual report for each year and a plan for proposed annual activities for the upcoming year before the Founder of the Trust (Alumni Association).
- (xvi) To take all such actions/decisions as it may consider necessary or expedient for achieving the aims and objectives of the Trust (Alumni Association) with prior approval of the Founder.

## 12. PRESIDENT

The President of the Trust (Alumni Association) shall be nominated by the Founder. The President shall have the following powers and duties:

- (i) To preside over the meetings of the Trust (Alumni Association).
- (ii) To supervise and exercise general control over the affairs of the Trust (Alumni Association).
- (iii) To ensure that the decisions of the Governing Body are implemented as per its true letter and spirit.







- (iv) To update the Founder from time to time regarding activities of the Trust (Alumni Association).
- (v) To constitute committees, sub-committees for particular works related to functioning and administration of the affairs of the Trust (Alumni Association).
- (vi) To call for an explanation from the employees of the Trust (Alumni Association) if and when required.
- (vii) To do all such acts, deeds and things necessary for carrying out the functions of the Trust (Alumni Association) as assigned by the Founder or the Governing Body.

### **13. VICE PRESIDENT**

The Vice President of the Trust (Alumni Association) shall be nominated by the Founder. The Vice President shall report to the President. The Vice President shall officiate as President in the absence of the President and any decision taken by him shall be subject to ratification by the President of the Trust (Alumni Association). The Vice President shall chair the meeting of the Trust (Alumni Association) in absence of the President. The Governing Body or the President may assign any specific task to the Vice President.

### **14. GENERAL SECRETARY**

The General Secretary of the Trust (Alumni Association) shall be nominated by the Founder. The General Secretary shall report to the President. The General Secretary shall have the following powers and duties:

- (i) To convene the meetings of the Governing Body of the Trust (Alumni Association) after consulting the President.
- (ii) To circulate notices, agenda and minutes of the meeting to all the members of the Governing Body.





- (iii) To prepare the Annual Report of the Trust (Alumni Association) and present before the Governing Body.
- (iv) To maintain documents and records of the Trust (Alumni Association).
- (v) To liaison with all Government offices and authorities.
- (vi) To record the proceedings of the meetings of the Trust (Alumni Association) and Governing Body and maintain a proper record of these meetings.
- (vii) To maintain and manage all the movable and immovable properties of the Trust (Alumni Association).
- (viii) To do all such acts, deeds and things necessary for carrying out the functions of the Trust (Alumni Association) as assigned by the Founder or the Governing Body or the President.

#### **15. JOINT SECRETARY**

The Joint Secretary of the Trust (Alumni Association) shall be nominated by the Founder. The Joint Secretary shall report to the Secretary. The Joint Secretary shall officiate as Secretary in his absence and any decision taken by the Joint Secretary shall be subject to ratification by the Secretary of the Trust (Alumni Association). The Founder/President/Secretary Body may assign any specific task to the Joint Secretary.

#### **16. THE TREASURER**

The Treasurer of the Trust (Alumni Association) shall be nominated by the Founder. The Treasurer shall report to the President. The Treasurer shall have following powers and duties:

- (i) To keep the day to day records of the financial affairs (including income and expenditure) and produce the same for audit.
- (ii) To supervise and control the finances and bank accounts of the Trust (Alumni Association).








- (iii) To prepare and present the annual budget and annual accounts of the Trust (Alumni Association).
- (iv) To look after the management of the properties, assets and investments of the Trust (Alumni Association) and update the Governing Body and President on the same.
- (v) To advise the Governing Body in regard to financial policies of the Trust (Alumni Association) as and when required.
- (vi) To prepare periodical reports of the financial affairs of the Trust (Alumni Association) and to present the same before the Governing Body from time to time.
- (vii) To do all such acts, deeds and things necessary for carrying out the functions of the Trust (Alumni Association) as assigned by the Founder or the Governing Body or the President.

#### **17. MEETINGS OF THE GOVERNING BODY**

- (i) The Governing Body shall hold at least three meetings in an English Calendar Year (from January to December). However the General Secretary in consultation with the President may call an emergency meeting as and when required.
- (ii) A prior notice of meeting shall be served by the General Secretary to all the members in writing by post/email/fax/courier at least 10 days before the scheduled date of the meeting.
- (iii) The meetings of the Governing Body of the Trust (Alumni Association) shall be held at its registered address or at any place as decided by the President.
- (iv) A meeting of the Governing Body of the Trust (Alumni Association) shall be deemed to have been held if the agenda is circulated and the opinions of





the members have been expressed by post or electronic mail or over the video conferencing.

---

- (v) Proceedings of meeting of the Governing Body of the Trust (Alumni Association) shall be recorded by the Secretary of the meeting and shall be signed by the Secretary and Chairperson of the meeting. Any resolution not recorded therein shall be Null and Void and non-est.
- (vi) The quorum for the meeting shall be two-thirds of the total members. If the meeting is adjourned for want of quorum, the adjourned meeting shall be convened after two hours on the same day to transact the business and members shall form the quorum. The decisions taken in the convened meeting shall be valid for all purposes. An item or business that has not been included in the agenda circulated to the members cannot be taken up at such a re-convened meeting.
- (vii) Each member shall have one vote. Decisions at a meeting shall be taken by simple majority. In case of a tie, the Chairperson shall have the right to cast the deciding vote.
- (viii) Each member shall make an endeavor to attend the meetings of the Governing Body of the Trust (Alumni Association) in person but, if for any reason it is not possible to do so, he may appoint any other member, in writing signed by him, as a proxy and the said proxy then shall have a right to vote on behalf of the absentee member. In case of meeting held over video conferencing, each member participating therein shall be counted as part of quorum.
- (ix) Any other person not a member or connected with the Trust (Alumni Association) may be invited for a meeting as a special invitee for advisory purposes; such invitee shall not have a right to vote. It shall not be obligatory on the Governing Body of the Trust (Alumni Association) to accept or consider the advice and opinion of the special invitee.





- (x) In case any member refuses to act and/or perform his duty or acts in a manner which hampers the administration of the Trust (Alumni Association) or is against the interest of the Trust (Alumni Association), he may be removed by the Governing body with a written notice of one month and the vacancy so caused shall be filled up in the manner specified in this deed.
- (xi) A signed copy of the minutes of each meeting of the Governing Body of the Trust (Alumni Association) shall be sent to the Founder of the Trust. If the Founder feels that the decision is not in the interest of the Trust (Alumni Association), the Founderafter taking opinion of the President and Secretary, shall give such directions to the President and Secretary as the Founder may deem fit. The President and Secretary shall implement the directions given by the Founder.
- (xii) In case of any indecisiveness with regard to any matter, including the interpretation of this Trust Deed, the matter shall be referred to the Founder, whose decision/interpretation shall be final.

#### **18. CORPUS OF THE TRUST (ALUMNI ASSOCIATION)**

- (i) To start the Trust (Alumni Association), the Founder has given a sum of Rs. 1,00,000/- (Rupees One Lakh) only, which shall form a corpus of the Trust (Alumni Association). The Founder hereby conveys, transfers and grants unto the Trust (Alumni Association) the said sum of Rs. 1,00,000/- (Rupees One Lakh) only and to have and to hold the same in Trust (Alumni Association) for the objects of the Trust (Alumni Association) as described herein, to be used and appropriated by the Governing body of the Trust (Alumni Association) in order to carry out and fulfil the said objects.
- (ii) The Trust (Alumni Association) may receive further contributions towards the corpus fund. The said corpus will not be disturbed and only the benefits arising therefrom shall be utilized for the administration of the Trust (Alumni Association). The Fixed amount of the Corpus shall not be decreased but may be further increased by the Governing Body depending upon the contributions being received by the Trust (Alumni Association).





## 19. ACCOUNTS

- (i) The account(s) of the Trust (Alumni Association) shall be opened in any nationalized/scheduled banks.
- (ii) The account(s) shall be operated by two out of three members as may be appointed by the Governing Body of the Trust (Alumni Association).
- (iii) The Founder of the Trust (Alumni Association) shall have the right to direct the banker to stop payment on any cheque which has already been issued if so required.

## 20. INCOME & PROPERTIES OF THE TRUST (ALUMNI ASSOCIATION)

- (i) The funds of the Trust (Alumni Association) shall include the Corpus Fund and any other fund received as membership fee, donations, gifts, bequest etc. The Trust (Alumni Association) may receive any financial help/grant from government and non-government organizations/bodies.
- (ii) All property (movable/immovable) shall be purchased in the name of Trust (Alumni Association) and shall vest in the Trust (Alumni Association). The members shall not have any personal right or interest therein.
- (iii) The Governing Body, with prior approval of Founder, will have power to borrow money on the security of Trust (Alumni Association) properties.
- (iv) The properties of the Trust (Alumni Association), with prior approval of Founder, may be transferred by way of Sale, Gifts, Mortgage, lease and /or exchange in accordance with this deed.
- (v) No part of the Trust (Alumni Association) property, either the corpus or income therefrom, shall be utilized for any purpose other than the purposes for which the Trust (Alumni Association) is created.
- (vi) All income of the Trust (Alumni Association) howsoever derived shall be applied towards the promotion of the objectives of the Trust (Alumni Association). No part of the income or property of the Trust (Alumni Association) shall be used for any other purpose.







Association) shall be paid or transferred directly or indirectly by way of dividend, bonus, gifts, profit or otherwise to any person including the members of the Trust (Alumni Association). Nothing herein contain shall prevent the payment made in good faith, towards reimbursement to the members thereof or other persons for travelling allowance, halting, the expenditure made by the members for any amount paid by them in discharge of their duties of the Trust (Alumni Association) or other similar charges with the approval of the Governing Body.

## **21. GENERAL**


- (i) The Governing Body may make Rules with regard to the efficient functioning and conduct of business and administration of the Trust (Alumni Association). The Rules so made may be amended or repealed by the Governing Body. If the Founder feels that the rules so made are detrimental for the functioning/administration of the Trust (Alumni Association), the Founderafter consulting the President and Secretary of the Trust (Alumni Association), may direct the Governing Body to amend the same. The direction given by the Founder shall be binding on the Trust (Alumni Association) and the Governing Body shall make necessary amendments as suggested by the Founder.
- (ii) The members of the Trust (Alumni Association) shall not be entitled for any salary. However they shall be entitled for reimbursement of the amount they have paid in discharge of their duties.

## **22. DISPUTE/CONFLICT**

All disputes/conflicts shall be resolved by the Governing Body. Any person aggrieved by such decision shall have the right to appeal within 30 days of communication of such a decision before the Founder of the Trust (Alumni Association) whose decision shall be final and binding.

## **23. LEGAL**

- (i) All legal actions for and against shall be in the name of the Trust (Alumni Association) through its President/Secretary.





- (ii) The Governing Body shall have the right to authorize any member/office bearer to deal with all legal matters and proceedings related to Trust (Alumni Association) and also to appoint an Advocate or any consultant or others, as the Governing Body deems fit and proper to protect the interest of the Trust (Alumni Association). The powers so given shall include the power to initiate and defend all legal proceedings in any court of law or before any authority.
- (iii) All/any dispute shall be subject to the jurisdiction of Courts of Uttarakhand.

#### **24. DISSOLUTION OF THE TRUST (ALUMNI ASSOCIATION)**

- (i) The Trust (Alumni Association) is created for the aims & objectives mentioned in Clause 05 (five) of this deed. On identification of mismanagement, mal-administration, indiscipline, failure in the accomplishment of the aims & objectives of the Trust (Alumni Association), the Founder may issue directions to the Governing Body of Trust (Alumni Association) to rectify the same. If the directions are not followed within the prescribed time, the Founder may take decision regarding dissolution of the Trust (Alumni Association).
- (ii) In the event of dissolution of the Trust (Alumni Association), the entire funds be realized and first be used for payment of liabilities of the Trust (Alumni Association). The assets left if any, shall be transferred and vest in the Founder of the Trust (Alumni Association) i.e. Swami Rama Himalayan University.
