# MEMORANDUM OF UNDERSTANDING (MOU)

This MOU is made on this 27<sup>th</sup> day of May in the year 2017,

### **BETWEEN**

Swami Rama Himalayan University (SRHU) having its registered office at Swami Ram Nagar, Jolly grant, Dehradun 248016 through its Registrar Mr. Nalin Bhatnagar (hereinafter called as the 'First Party').

#### AND

Uttarakhand Space Application Centre, (USAC) Dehradun is the nodal agency in Uttarakhand State for space-technology related activities having its registered office at

The terms 'First Party'& 'Second Party' shall, unless excluded by or repugnant to the context, include its successors, executors, administrators and legal representatives and permitted assigns.

The First Party & Second Party shall hereinafter be collectively referred to as "Parties" and individually as "Party".

WHEREAS Swami Rama Himalayan University (SRHU) is established under section of 2(f) of the UGC Act 1956 and enacted by Uttarakhand Act no 12 of 2013. The Swami Rama Himalayan University has been established with an objective to provide for instruction, teaching, training and research in such branches of study as the University deems appropriate including medical sciences, dental sciences, nursing, pharmacy, paramedical and allied health sciences, science, engineering & technology, biotechnology, yoga sciences, management, rural development, humanities and other branches of higher education.

AND WHEREAS Uttarakhand Space Application Centre, (USAC) Dehradun is the nodal agency in Uttarakhand State for space-technology related activities and has the mandate to employ space-technology for the benefit of the State and its people. It was constituted as an autonomous organization in 2005, under the Department of Science & Technology, Government of Uttarakhand. The prime objective of USAC is to explore and deploy geospatial technology for the development of State. Consequently, USAC boasts of a close relationship with the Indian Space Organization (ISRO) that has benefited the researchers & students to explore the opportunities and able to provide a platform for their research/training curiosity. USAC is working on various areas and has been providing services in the field of remote sensing, Geographical Information System, Global Positioning System, Photogrammetry, Software Development, Satellite communication, and Capacity building for providing training & technical knowledge to line department officers, collaborators, students and research scholars from the Universities.

#### **OBJECTIVE**

The objective of this MOU is to bring the SRHU & USAC together to collaborate in Knowledge sharing in the areas of research and training of faculty members & students. To **strengthen and make** this collaborative effort a success, SRHU and USAC have decided to enter into this Memorandum of Understanding (MOU) on the terms and conditions agreed herein.

## Following are the general Terms & Conditions:-

- 1. That MOU shall be valid for a period of Three (03) years from the date of its execution i.e. from 27/05/2017 to 26/05/2020. The MOU can be further renewed and/or a fresh MOU be executed for further period on mutually agreed terms and conditions between both the Parties.
- 2. That in the case of either party wishing to discontinue/terminate the MOU within the period of its tenure, they shall do so by giving a one month advance notice.
- 3. Obligation of the First Party i.e. Swami Rama Himalayan University is to:
  - a) Share knowledge in terms of research projects by faculty and students rendering to USAC's objectives
  - b) Provide access to field visits and network in USAC programmes
  - c) Contribute in different capacities in the research projects of USAC through researchers of SRHU
  - d) Help and contribute in publishing the research work for collaborative studies
  - e) Link USAC's various projects for students level
- 4. Obligation of the Second Party i.e. Uttarakhand Space Applicaton Centre is to:
  - a) Help in Mentoring and guidance of students of SRHU in course projects/research
  - b) Provide Training and internship programmes to the students of SRHU
  - c) Provide the lab facility for research and training and internship programmes for students
  - d) Provide knowledge sharing for contribution of publications in national and international papers
  - e) Partner in collaborative research with SRHU and disseminate joint work at national and international conferences and such other platforms
- 5. Joint responsibilities of the both the Parties and general terms & Conditions:
  - a) That both the parties shall work together to raise funds, projects etc. to support mutual research work and get collaborative research works, projects, project proposals, publications etc. of mutual interest and joint ownership of such projects/programmes/publications.

- b) That both the parties shall collaborate and work with each other to jointly host various meetings, conferences, seminars etc.
- c) That the research findings published by either party shall give credit to other party's contribution with acknowledgements to funder and partners but the party publishing them shall be entirely responsible for conclusions and interpretations reported.
- d) That the names of both the parties shall be published with the research / internship reports.
- e) That the MOU is open to modifications, amendments or changes as per the future mutual requirements between both the Parties. No amendment to this MOU shall be valid or binding unless set forth in writing and duly signed by the Parties.
