Swami Rama Himalayan University, Swami Rama Nagar, Doiwala, Dehrudun - 248140, Uttarakhand is not authorized to open study centre/ off campus centre beyond the territorial jurisdiction of the state as per the judgment of Hon'ble Supreme Court of India in case of Prof. Yeshpai Vs. State of Chhattisgarh. The University cannot open its centre(s) even within the state as per the provision of UGC (Establishment of and Maintenance of Standards in Private Universities) Regulations, 2003 without the approval of UGC.

The UGC has not grant any approval to the University to open off campus/study centre.
