#### Mode of Payment:

- Candidates, who have been allotted the seat, are required to pay Rs.50,000/- (Rupees Fifty Thousand Only) to secure admission on the day of counseling failing which he/she shall have NO CLAIM whatsoever on the seat allotted through counseling.
- 2) Remaining amount of fees must be deposited within a week.
- 3) Fees can be deposited bank demand draft drawn in favour of Swami Rama Himalayan University or through RTGS / NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580
- 4) Admission Order can be obtained from Himalayan College of Nursing after submission of the fees mentioned in Allotment Order and physical verification of the documents from original documents.

#### NOTE:

- 1) Allotment of seats will be done strictly on merit basis prepared on the basis of marks obtained in last qualifying examination, subject to verification of original certificates/documents of the candidates. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding on the day of counseling as per the schedule
- 2) All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found during physical verification or at a later stage, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
- 3) All allotments are subject to the authenticity of facts from the verification of original certificates/documents of the candidates before receiving Admission Order from Himalayan College of Nursing. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding.
- 4) If the candidate leaves the program before 30<sup>th</sup> September 2025, the Admission Fees shall not be refunded. In case the candidate wants to discontinue the program after 30<sup>th</sup> September 2025 then he / she shall be required to deposit the fee for the entire duration of the program.
- 5) As per the orders passed by the Apex Court, the candidate is required to furnish either bank guarantee or post-dated cheques for the fee payable for the remaining period of the course.
- 6) Therefore, all candidates who obtain admission at Himalayan College of Nursing shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee of the entire duration of the course, as cash security.
