This Comprehensive Positron Emission Tomography Scan (PET CT Scan) Services Agreement ("Agreement") is made on this 21 September, 2020 by and between,

Swami Rama Himalayan University (SRHU), for one of its teaching hospitals 'Cancer Research Institute' with PAN AAAJH0463L having Registered Office at Swami Ram Nagar, Jolly Grant, Dehradun, Uttarakhand – 248016 through its Registrar Mr. Nalin Bhatnagar, (hereinafter referred to as the "First Party" or "SRHU). Himalayan Institute Hospital Trust, a Society registered under the Societies Registration Act, 1956 is the promoting society of the Swami Rama Himalayan University

Ltd. a company incorporated and registered under the Companies Act, 1956, with PAN Number <u>AABCC8628G</u>, having its registered office at <u>k-16, South Ex Part-1</u> New Delhi -110016, India and represented by <u>Mr. Rahul Sanan</u> (hereinafter referred to as the 'Second Party' or "DIFI").

The terms 'First Party' or "SRHU" & 'Second Party' or "DIFI" shall, unless excluded by or repugnant to the context, include its successors in interest, legal representatives, nominees, permitted assigns etc. The First Party & Second Party shall hereinafter be collectively referred to as "Parties" and individually as "Party".

WHEREAS

- A. The Himalayan Institute Hospital Trust (HIHT), is a Society involved in charitable activities in the field of healthcare and education and is the promoting Society of Swami Rama Himalayan University (SRHU).
- B. The Swami Rama Himalayan University (SRHU), the First Party is engaged in running a 1000 bedded teaching Hospital, 'Himalayan Hospital', along with a 250 bedded 'Cancer Research Institute' which provides in-patient and out-patient services to the patients of Uttarakhand, and desires to have a "PET CT Scan" within the premises of its teaching hospital located at Swami Rama Himalayan University, hereinafter referred to as "Hospital".
 - C. The DIFI Healthcare Private Limited, the Second Party is an established company operating a chain of standalone PET CT Scan Centers under the name and style "DIFI".
 - D. The First Party attests that it is in lawful possession of the property and has a clear, absolute, unrestricted title and ownership rights with respect to the premises at 'Cancer Research Institute' (hereinafter referred as the "CRI") and has wholeheartedly agreed for the other parties to setup PET CT Scan Centre.
 - E. The Second Party has approached the First Party for installing, operating, running and managing the PET CT Scan Center for the diagnosis of the patients.
 - F. That the Second Party is taking lease finance from TATA CAPITAL FINANCE COMPANY LIMITED for the purchase of PET CT Scan equipment & TATA CAPITAL FINANCE COMPANY LIMITED has sanctioned the lease finance vide its sanction letter no. CF/OL/Del/3262240 dated 21.08.2020 as attached as **Annexure-1**.
 - G. The First party has accepted the proposal of the Second Party and have agreed to provide the space required by the Second Party for the purpose of installing, operating, running and managing the PET CT Scan Center in the premises of the Cancer Research Institute as detailed in Annexure--2 and for providing the PET CT Scan services and other required assistance set forth in this Agreement, upon the terms and conditions set out herein below.
 - H. This agreement shall be deemed to be effective from 30th September, 2019.

Registrar Swami Rama Himalayan University NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND AGREEMENTS SET FORTH IN THIS AGREEMENT AND FOR OTHER GOOD AND VALUABLE CONSIDERATION, THE RECEIPT AND SUFFICIENCY OF WHICH ARE HEREBY ACKNOWLEDGED, THE PARTIES HERETO AGREE AS FOLLOWS:

- 1. **PET CT Scan Center Premises**: In consideration of the financial consideration agreed upon herein under this agreement, the First Party has agreed to provide the Second party a space as per the AERB guidelines within the Cancer Research Institute at a mutually agreed location, ("PET CT Scan Center Premises") of which the Map is attached herewith as (**Annexure—2A**) for the purpose of setting up the PET CT Scan Center. The First Party shall hand over the possession of the said Premises within 15 (Fifteen) days from the Effective Date of this Agreement.
- 2. Access & Assistance to Second Party: The First Party, its employees, doctors, contractors, representatives, patients, visitors and authorized agents shall have unrestricted/unlimited access to the PET CT Scan Center Premises 24 hours per day and 7 days per week, 365 days a year during the term of this Agreement. The First Party & Second Party shall together, within minimum reasonable time from the Effective Date, obtain all necessary permissions and empanelment as listed in Annexure-- 3 as applicable, from the concerned authorities for the purposes of running the PET CT Scan Center at the Cancer Research Institute. The First Party hereby agree to extend all necessary assistance and co---operation, including but not limited to execution of requisite forms, applications and other documents required by the Second Party and as and when the need arises.
- 3. **Property**: The First Party attests that they have paid for all the civic dues on the property for PET CT Scan Center Premises till the effective date of this agreement and will continue to do so during the "Term" of the agreement.
- 4. **Installation of Machines, Furniture & Fixtures**: The Second Party shall be entitled to carry out such works and activities as are required by it to fit out and furnish the PET CT Scan Center Premises in a manner which it deems fit and proper including but not limited to modifications as per AERB requirements, installation of PET CT Scan, erection of wooden partitions, counters, erection of fittings, fixtures, installations of requisite equipment, computers, automation equipment, or any other materials, furniture, fittings, goods, or paraphernalia including the civil works as may be necessary for PET CT Scan Center.
- 5. **Responsibilities**: The Parties acknowledge that the revenues of the PET CT Scan Center and the Cancer Research Institute would increase with the endeavors of both the Parties. Further, in consideration of the healthcare services arrangement agreed under this Agreement, the Parties have agreed for certain inter-se responsibilities, as described in **Annexure--4**, to be undertaken by each Party from the time the PET CT Scan Centre is established.

6. **Signage**: The First Party and the Second Party shall be entitled to do internal branding at PET CT Scan Center. Second Party shall display co-branded standees at the CRI premises. However the Project will be branded and promoted under the following Brand name:

'CRI PET CT Scan Centre - SRHU (Logo) In association with

DIFI Healthcare Private Limited (logo)'.

Note: All the logos with the same size representing equality and fairness. Second Party shall also share all the signage designs with the First Party.

- 7. **Non-Interference in Operations**: Subject to observance of terms of this Agreement, the Second Party shall during the term of this Agreement be entitled to run the PET CT Scan Center from the CRI Premises without any interruption with respect to staff, scheduling, or any other operational aspects by the First Party or any person or persons claiming by, from, and under or in trust for it. Additionally, It has been explicitly agreed by the Parties that the First Party shall not engage any other PET CT Scan operator, PET technician or any other competing Medical Physicist or service provider in the Cancer Research Institute.
- 8. Sublet: During the tenure of this agreement the Second Party shall not outsource /Sublet /PET CT Scan to any other party within the campus and shall ensure that no other activity is carried out in the premises.
- 9. Second party shall not intentionally transfer any PET CT Scan patient of SRHU to any other PET CT Scan center for earning better revenue share.
- 10. Payment Terms:
- a) The Parties agree that the all OP and IP PET CT Scans billing will be done by the First Party.

The Revenue share between the parties shall be as per the **Annexure-- 5**.

- b) That the Parties shall calculate the cash patient's revenue share (as detailed in Annexure -5) as agreed upon and settle the calculated dues by last date of following month.
- c) That in case of credit patient the first party shall settle the revenue within 45 days after receiving the payment from concerned govt. authorities/ credit organization or shall settle the revenue within 180 days from the last day of service provided month, whichever is earlier.
- d) The Second Party shall support the First Party for bill claiming process including filing, online loading & documentation.
- e) Further, if the said dues are not paid or cleared within 30 days from the expiry of Due Date, then the aggrieved Party (i.e. the Party whose dues are not cleared within Due Date) shall have the right to set-off such dues from the amount payable by such aggrieved Party to Other Party.

11. Term and Termination:

- a. This Agreement shall come into effect from the Effective Date of this the Agreement and shall be valid for a period of 10 (Ten) years plus the Development Period of 6 months to build the PET CT Scan Centre from the Effective Date ("Term") with an option to extend further.
- b. **Termination with cause:** If there is material breach of contract by either Party, the Other Party shall give 3 months notice for remedy and failing which, the Other Party shall have a right but not the obligation to terminate the Agreement with a month's notice.
- That in case the Second Party fails in making monthly payment to the TCFCL or makes defaults(s) as per clause 16 & 17 of the master lease agreement dated 03.09.2020 executed between DiFi & TCFCL and the TCFCL notifies the First Party for the possession of the equipment, the Second Party shall continue to deliver all required supplies viz. radio isotopes, reagent, technical assistance, etc. which are necessarily needed for operating/running the equipment for next 03 months from the date on which TCFCL furnish the possession notice to the First party.
 - d. That in case the First Party found that the Second Party is indulged in any unethical practices, the First Party may call justification from the Second Party and the Second Party shall justify his act within 30 days of receipt of such notice failing which the First Party shall have the Right to terminate the agreement after giving a month's notice.
 - e. First Party or the Second Party shall not terminate the agreement for the potential financial benefits coming from partnering with any other entity.
 - f. That this agreement can be reviewed on yearly basis and may be amended by both the parties on mutual consent.
 - 12. Limitation of Liability: The First Party shall hold harmless and indemnify the Second Party from all issues related to Premises or unrelated to PET CT Scan Center and attests that such matters are purely the responsibility of the First Party. Similarly, The Second Party shall indemnify and hold the First Party harmless for all issues related to PET CT Scan that may arise in the Cancer Research Institute, patient care, including Fire related accidents.
 - 13. Representation Pertaining to Construction of Hospital: The First Party & Second party have expressly warranted that the Cancer Research Institute including PET CT Scan Center Premises have been constructed in consonance with all applicable local, municipal or state laws and shall at all future times continue to adhere to all the laws. In the event of there being any defect or deficiency or inadequacy in the First Party's right to execute this Agreement and/or the First Party thereby is

unable to use the PET CT Scan Center Premises in a way the First Party intends the use the PET CT Scan Center Premises, due to non-adherence to hospital construction laws, the First Party undertakes, to fully indemnify the Second Party against all consequences arising there from including damages, losses, costs or any other claims and demands relating thereto.

- 14. Insurance: The Second Party shall ensure insurance for their PET CT Scan Center's assets.
- 15. Notices: Any notice consent, waiver and/or other communication pursuant to this Agreement must be in writing signed by the person serving it or by a person duly authorized by the person serving it and will be deemed to have been duly given when (a) delivered by hand (with written confirmation of receipt); or (b) when received by the addressee, if sent by a recognized overnight delivery service (receipt requested), in each case to the appropriate addresses set forth below (or to such other addresses as a Party may designate by notice to the other Party):

- **16. Arbitration**: The parties herein shall resolve all disputes in connection with this agreement amicably by mutual negotiation, failing which, the parties herein shall refer the dispute for arbitration in accordance with the Arbitration and Conciliation Act, 1996, with its statutory modifications, enactments or re-enactments thereto. The place of arbitration shall be Dehradun.
- **17. Governing Law and Jurisdiction**: This Agreement shall be governed and interpreted in accordance with Indian laws and any legal action or proceeding arising under this Agreement shall be subject to the jurisdiction of the courts of Dehradun.
- 18. Confidentiality: Each of the Parties shall maintain the utmost confidentiality, regarding the contents of this Agreement at all times, and no Party shall use or disclose any confidential information of the other Party for any purpose other than as explicitly permitted by this Agreement, without the prior written consent of such other Party. Provided however nothing contained herein shall affect the ability of the Parties to make disclosure to any governmental authority or any other person under the

provisions of any applicable law, provided however in all such circumstances, the disclosing Party shall give prior notice to the other Party before making the disclosure, indicating the nature of information that is proposed to be disclosed and in sufficient time to allow the other Party to seek confidentiality of the information being disclosed, to the extent permitted by law.

19. Emergency Response and Support: First Party agrees to assist Second Party's staff and doctors in any or all emergencies at the PET CT Scan Center. First Party shall ensure availability of quick action in emergency through its professionals who are trained in emergency care including but not limited to nursing staff, resident doctors, specialists and also provide emergency management equipment as needed. First Party also agrees for priority access to the ICU or Casualty/Triage/Emergency for any or all patients of PET CT Scan Center in the event of an emergency. The First Party shall share emergency helpline numbers with the Second Party that will be displayed by the Second Party both within the PET CT Scan room and the reception area. It is also agreed that the First Party shall inform all their staff including but not limited to resident doctors, specialists, nursing and paramedical staff about the emergency handling agreement with the Second Party, so there will be full co-operation in the event of an emergency. For Example: In case of cardiac arrest, Second Party's staff may contact the First Party via the emergency number provided by the First Party and announce Code Blue at the PET CT Scan Center. A team of BLS (Basic Life Support)/ACLS (Advanced Cardiac Life Support) trained physicians or staff, from First Party, should respond immediately to such emergencies and assist the Second Party's staff in stabilizing the patient.

20. Miscellaneous

- a. That this Agreement may be amended only by an instrument in writing signed by each Party to this Agreement.
- b. That the Parties shall have the right to use the name & trademark of the other Party or do any press release only for the purpose of publicity of the PET CT Scan Center with prior approval of both parties.
- c. That the First Party being an academic Institution shall have the right to use the clinical data arising out of the PET CT Scan Center for research purposes.
- d. That the Second party shall provide add on facilities on the PET CT Scan equipment for Radiotherapy Simulation planning (ON AGREED RATE).
- e. That the second party will upgrade the PET CT machine from time to time synchronizing with the advancement of available technology.
- f. That both the parties shall make best endeavor to reach the monthly target of 200 PET CTs and in case the monthly target is not reached within 6 months after execution of this agreement the
