The First Party & Second Party shall hereinafter be collectively referred to as "Parties" and individually as "Party".

NOW both the parties agree to work together in the following areas:

General Terms & Conditions:-

1. That MOU shall be valid for a period of 05 (five) years from the date of its execution i.e., from 15/07/2024 to 14/07/2029. The MOU can be further renewed and/or a fresh MOU be executed for further period on mutually agreed terms and conditions between both Parties.
2. That in the case of either party wishing to discontinue/terminate the MOU within the period of its tenure, they shall do so by giving a one month advance Notice.
3. This engagement is subject to mutual agreement and satisfactory accomplishment of the common Objectives.
4. No Partnership: Nothing in this Agreement is to be construed to make party a partner, an agent or legal representative of the other for any purpose. Neither Party has any right or authority to accept any service of process or to receive any notices on behalf of the other Party or to enter into any commitments, undertakings, or agreements purporting to obligate such other Party in any way, or to amend, modify or vary any existing agreements to which such other Party may

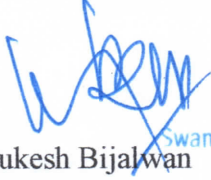

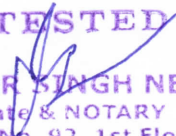
