- Research partnership: The institute and the company may collaborate for research activities, expertise services further facilitating use of institute's research capabilities and resources for sample analyses, consultancy services.
- Product Developments- Both institute & Company may collaborate to fuel new innovative technologies towards joint products developments & solutions in medical & non-medical fields.
- Motivational Sessions: The institute and the company may collaborate on enhancing the capabilities of students of SRHU on administrative Leadership Management skills.

- Digital Safety Skills The Company may facilitate modules on Digital Awareness,
  Digital Safety, Cyber Hygiene, Cybersecurity, Cyber Laws, Cyber-crime Prevention,
  Cyber Safeguards, Social Engineering Training Programs for the students & Staff of
  SRHU with a mission to empower them as safe Digital Naagrik.
- Counselling & Therapy The institute and the company may collaborate & exchange
  their expertise services to provide psychological, emotional, mental health support
  and guidance to the victims of Crimes especially victims of Cyber Crimes & their
  families.
- Holistic Lifestyle The institute & the company may collaborate in the areas of indigenous Sports development, Physical & mental fitness, all-round development of students, Staffs & Society as a whole.
- Any other activities as may be mutually agreed upon.

## 4. Mode of operation

Both parties will provide necessary support for effective implementation of the MoU within the institutional rules and procedures.

- A. This MoU shall be effective from the date it is signed by both the parties
- B. Any financial commitment for joint activities under this MoU shall be subject to the approval by the competent authorities of the respective organizations
- C. The activities under this MoU shall be coordinated, monitored and recorded by an Internal Coordination Committee. The designated person as nominated by the competent authority shall be the internal coordinator from SRHU, whereas Binod Dobhal (Founder MD & CEO) will be the internal coordinator from Findfin Foundation.

#### 5. Financial arrangements

This MoU places no financial obligations or supplementary funding commitments on either Party. These activities will be defined through separate programme agreements, detailing the commitment of resources (financial or otherwise) required from each institution. Subsequent programme agreements must be approved in writing by the authorized representatives from both Parties. Each Party will be responsible for its own costs in connection with all matters relating to collaborations under this MoU.

#### 6. Non-disclosure

Either party shall not provide or disclose any confidential information related to the other party, acquired during the cooperation or exchange stated herein, to a third party (except as required under law disclosure to any governmental authority or any other person under the provisions of any applicable law).

## 7. Principle of good faith

The parties shall practice this MoU in good faith.

#### 8. Validity

This MoU will become effective on the date of signatures by both Parties. It will remain valid for a period of five (05) years from the date of the last signature, with the understanding that it may be modified / renewed by written mutual consent of both the Parties. This MoU may be terminated by either Party with advance written notice of at least thirty (30) days. The terms of this MoU may be amended with the consent of both the Parties.

## 9. Indemnity

Either party agrees to defend, indemnify and shall accordingly hold harmless the other party, its directors, officers, employees, agents and affiliates ("Indemnified Person") from and against any losses or liabilities caused by the defaulting party, its directors/trustees, officers, employees or agents ("Personnel") and from any and all claims, damages, consequences, exposure, outgoings, prejudices, costs, taxes, duties, penalties and interest thereon or expenses of any kind, including reasonable attorney's fees and legal costs (incurred whether in protection or defense) which may be incurred by or asserted against the Indemnified persons on account of or arising out of or resulting from the acts, omissions, negligence or intentional misconduct of defaulting party and/or its Personnel, any bodily injury or destruction of tangible property, any claims for breach by the defaulting party of any of its obligations contained in this agreement or any violation of applicable laws.

## 10. Governing laws and disputes resolution

- This MoU, shall in all respect, be governed by and construed in accordance with the laws of the Republic of India.
- 2) Any unresolved dispute shall be referred to the management of Findfin Foundation and SRHU. An independent arbitrator shall be engaged with mutual consent in accordance with Arbitration and Conciliation Act, 1966 and rules framed thereof. Arbitration shall be conducted at Dehradun. The decision of arbitrators so reached shall be final and binding on both the Parties. Language of arbitrator shall be English.
- 3) Each clause of this MoU is severable and if one clause is rendered illegal or is severed, it will not render the whole MoU illegal and all clauses except severed clause shall be valid and binding on both parties.
