Agreement

This Agreement is entered into 1st day of February in the year 2025,

By and between,

GREENPEDIA BIKE SHARE PRIVATE LIMITED (hereinafter referred to as "PARTY A") the party of the FIRST part having its registered office at 501/B Parshwa Tower, Behind Pakwan Restaurant, SG Highway, Bodakdev, Ahmedabad, Gujarat - 380054, through its Director, Mr. Arjit Soni.

And

Swami Rama Himalayan University, (hereinafter referred to as "PARTY B") is a University established under section 2(f) of the UGC Act & enacted vide Uttarakhand State Act, having its office at Swami Ram Nagar, Jolly Grant, Dehradun, Pin-248140, Uttarakhand, through its Registrar Commander Challa Venkateswar (Retd.).

1. Objective

WHEREAS THE PARTY A is engaged in the business of BICYCLE SELLING, RENTING and SHARING SYSTEM through its mobile application.

WHEREAS the PARTY B is a university which provides education, training and enable research area of medical science, nursing, science, engineering & technology, allied health sciences and other areas of higher education.

WHEREAS the PARTY B has approached PARTY A to sell 50 refurbished bicycle and to develop a bicycle sharing system for Swami Rama Himalayan University i.e. PARTY B.

AND WHEREAS PARTY A has agreed to sell 50 refurbished bicycle with bicycle sharing system to PARTY B and Both the parties on equality and mutual benefit to develop an environment-friendly bicycle sharing system on the terms and conditions mutually agreed upon as follows:

2. Scope of Services

PARTY A shall sell & deliver 50 refurbished bicycle to PARTY B at the cost of (Rs.735000/- + GST) detailed in Amexure 1 of this Agreement.

PARTY Beshirth Mages the bicycle within 30 days of delivery to ensure that the condition specification of Party B. Upon satisfactory inspection by the requirement of the Cycles shall be adjusted as agreed upon in Annexure 1.

PARTY A shall also provide complete maintenance and repair services for the 50 refurbished bicycles provide to PARTY B. These services shall include:

- a. **Preventive Maintenance:** Routine inspections, cleaning, tire pressure checks, brake adjustments, chain lubrication, and general upkeep of the bicycles, to be conducted on a Regular basis.
- b. **Corrective Maintenance**: Repairs and replacement of defective or worn-out parts, including tires, brakes, chains, and other components as needed.
- c. On-Demand Emergency Repairs: Responding to emergency maintenance requests within 1 hours of notification from PARTY B.

d. Software Updates: If applicable, updates for any digital components (e.g., tracking or smart lock systems) installed on the bicycles.

3. DURATION

- a. The agreement shall be deemed to be came into effect from 1st-February-2025 to 31st -January-2028 and shall remain valid for a period of 3 years.
- b. On completion of the said term, the period of the contract may be extended for a suitable period by mutual consent of both parties.

4. LOCATION

Swami Rama Himalayan University, Swami Ram Nagar, Jolly Grant, Dehradun, Pin-248140, Uttarakhand

5. RESPONSIBILITIES AND DUTIES OF PARTY A

- a. Party A shall maintain the cycle at the Rate (850/- per month + GST)
- b. Party A shall maintain 50 Refurbished Smart Pedal Bikes at Swami Rama Himalayan University, which will be available for use to the Students, Visitors, and Staff at the University Campus. Based on the requirement, number of bicycle may be increased as per the existing rates established.
- c. Party A shall be responsible for running & managing the bicycle-sharing system using its proprietary software and technologies.
- d. While the system will be accessible 24*7, customer care & back-office support will be available 7 days a week, 6 AM to 11 PM except for public holidays notified by Party A from time to time.
- e. Party A shall provide all necessary tools, parts, and equipment for the maintenance and repair of the bicycles within a maximum time limit of 24/48 hours.
- f. Party A shall Repair and replace the defective parts such as brakes, tires, electrical components, battery, chains, etc., as and when required due to wear and tear, accidents, or malfunction at no extra cost to the User.
- g. The safety and security of the bicycles from any loss, including but not limited to damage, or vandalism, shall solely be the responsibility of Party A.
- h. Party A shall maintain a record of all maintenance and repair work conducted on each bicycle and share the records with Party B on a monthly basis or whenever asked.

- m. Ensure that all bikes are safe and operational for Users.
- n. Provide emergency repair services as and when required.
- o. Party A shall deploy his representative/employee at the bike station to conduct preliminary checks and repairs on the bicycles before renting them out. The salary and accommodation and all other perks to his representative/employee shall be provided by Party A, and the employee shall be required to wear an identity card.
- p. Party A shall ensure that the User shall be made aware about the terms & condition set out in Annexure 2 and shall give his consent before using the bicycle. Party A agrees to provide the User with the Terms of Use prior to the commencement of bicycle services and shall take reasonable steps to confirm that the User has react, so understood, and acknowledged these terms & conditions.

6. RESPONSIBILITIES AND DUTIES OF PARTY B

- a. Party B shall provide need-based space at their premises in such a location as they deem fit for setting up a bike service station to Repair and maintain the bicycles.
- b. For the replacement of bicycles and for the purpose of redistributing cycles from stations where there is a surplus, to stations where there is a deficit of cycles, Party B will deploy a redistribution vehicle + driver (carrying capacity 5 cycles)

7. LIABILITY AND INDEMNIFICATION

- a. The Party A agrees to indemnify and hold harmless the Party B from any claims or liabilities arising out of lack of maintenance by the Party A staff.
- b. The Party A is responsible for any damage caused due to negligence or failure in performing the maintenance duties outlined in this Agreement.

8. DATA SECURITY AND PRIVACY

- a. The Party A agrees to handle all data in compliance with applicable data protection laws.
- b. No personal data of Users will be accessed, stored, or shared by the Party A without the express written consent of Party B.
- c. Any breach of data security must be reported to the Party B immediately.

9. CONFIDENTIALITY

- a. The Party A agrees to maintain the confidentiality of all information regarding the SRHU operations and will not disclose such information without prior written consent from the SRHU.
- b. Both parties agree to maintain the confidentiality of all Confidential Information disclosed by the other party. Neither party shall use, disclose, or allow access to the Confidential Information except as expressly permitted by this Agreement or as necessary to fulfill their obligations under the Agreement. Each party agrees to take all reasonable measures to protect the confidentiality of the other party's Confidential Information with the same degree of care that it uses to protect its own confidential information, but in no event less than a reasonable degree of care.

10.T PERMINATION

EVENT OF DEFAULT BY PARTY A

If Party A fails to fulfill its obligations as outlined in this Agreement, specifically concerning the maintenance and repair of the bicycles, Party B shall impose a penalty of Rs. 100 per day per bicycle for each incident of non-compliance. Such penalties may be deducted from any payments due to Party A under this Agreement or recovered through other legal means deemed appropriate by Party B.

12. FORCE MAJEURE

Neither party shall be held liable for any failure or delay in fulfilling its obligations under this Agreement if such failure or delay is due to an event beyond the reasonable

control of the affected party, including but not limited to acts of God, war, terrorism, natural disasters, epidemics, pandemics, strikes, lockouts, government actions or regulations, civil disturbances, or any other unforeseen events ("Force Majeure Events"). In the event of a Force Majeure Event, the affected party shall promptly notify the other party in writing of the nature and expected duration of the Force Majeure Event and shall take all reasonable steps to mitigate the impact of the Force Majeure Event

TERMS OF PAYMENT 13.

- a. The bicycle maintenance charges for the duration of the contract will be payable when Party A raises the bill for each quarter in advance. Party B will then make the payment within 45 days.
- b. Taxes (GST, etc.) will be charged extra as per the applicable rates at the time of raising
- c. The Bicycle Maintenance Charges shall include all costs towards 'general' repairs & maintenance.

JURISDICTION AND ARBITRATION 14.

- This Agreement shall be construed, interpreted and enforced in accordance with Laws of India.
- b. In case of any differences, both the parties, shall make all efforts to settle the disputes amicably through mutual discussion and negotiation, failing which, dispute(s) shall be referred to a sole Arbitrator appointed by both the Parties, as per provisions of Arbitration and Conciliation Act, 1996 including. Language of Arbitration shall be English and place of Arbitration shall be Dehradun, India.
- Subject to the Arbitration Clause, the Courts competent jurisdiction at Dehradun shall have exclusive jurisdiction in respect of any and all matters pertaining to this MOU
