

ADDENDUM TO SERVICE AGREEMENT DATED 15th JANUARY, 2025

This addendum forms a part of the Service Agreement dated 15th January 2025 between M/s Data Matrix expert Private Limited and Swami Rama Himalayan University, for providing complete consultancy services and to work as 'Nodal Agency' to co-ordinate in (a) NIRF including SDG category, (b) UGC-Deb-Online Programs, (c) QS I-GAUGE, (d) NAAC AQAR, (e) QS Asia University Ranking preparation, (f) Research Collaboration, (g) 12B application support and (h) Website support or three years commencing from 2025. To rectify the clause no. 5.2 of the service agreement regarding the payment of Travelling Allowance in case of consultant visit to the University to which both the parties hereby mutually agree to execute this addendum, which is to be read simultaneously with the Service Agreement. The clauses of the addendum shall supersede the respective clause contained in the Service Agreement dated 15.01.25.

Existing Clause No. 5.2 of the Service Agreement executed on 15.01.2025:-

5.2 'That in case the consultant visits the University campus, Travelling Allowance and accommodation will be paid by the university, as per actuals, subject to maximum payment of Rs. 12,000/- for travelling expenses and 5000 for Accommodation, incase accommodation is not provided by the University."

Now, clause no. 5.2 of the Service Agreement dated 15.1.2025 shall be read as :-

5.2 That in case the consultant visits the University campus, a fixed amount of Rs. 12,000/- shall be paid to the consultant for the travelling expenses and Rs. 5000/- for Accommodation, incase accommodation is not provided by the University.
