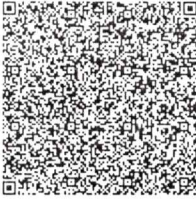

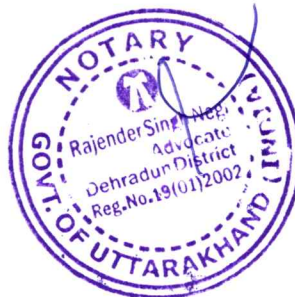

(hereinafter referred to as “**Donor**” which expression shall unless repugnant to or inconsistent with the context or meaning thereof, shall include its successors-in-interest, subsidiaries, affiliates and permitted assigns), of the **FIRST PART**;

AND

Swami Rama Himalayan University, a university established under section 2(f) of UGC Act and enacted vide Uttarakhand Act No. 12 of 2013 having its registered office at Swami Ram Nagar, P.O. Jolly Grant, Dehradun 248016 through its Registrar, Dr. Susheela Sharma R/o SRHU Campus, Swami Ram Nagar, Jolly Grant, Dehradun.

(hereinafter referred to as “**Donee**” which expression shall unless repugnant to or inconsistent with the context or meaning thereof, shall include its successors-in-interest, subsidiaries, affiliates and permitted assigns), of the **OTHER PARTY**.

Donor and Donee shall hereinafter be collectively referred to as “Parties” and individually as “Party”

WHEREAS

- a. Donor is a disciple of His Holiness Dr. Swami Rama and had donated a sum of Rs. 50,00,000/- (Rupees Fifty Lakhs Only) for promoting programs/courses related to the encouragement of the livelihood skills of the needy people.
- b. Donee is an organization that works in academic, research, health and education sector & also involved in the social awareness and philanthropic activities and primarily works on health, education & development, water & sanitation and also support vocational studies and Skill Development programmes.

1. PURPOSE

This Memorandum of Understanding, hereinafter called MoU, is for collaboration between Donor and Donee to provide funds to empower the Skills leading to strengthening the income and lives of the people in need.

NOW, THEREFORE, IN CONSIDERATION OF THE MUTUAL COVENANTS AND AGREEMENTS HEREINAFTER SET FORTH, THE PARTIES HEREBY AGREE AS FOLLOWS:

2. OBJECTIVES

The Objective of this MoU is to encourage the Skill Development programmes leading to the strengthening the lives and skills of needy people.

3. TENURE

This MoU shall be valid throughout the period until the funds donated by the First Party are completely utilized and shall come into effect from the date of its signing by both the parties.

4. OBLIGATION OF DONOR AND DONEE

DONOR

The Donor had donated a sum of Rs. 50,00,000/- (Rupees Fifty Lakhs Only) for promoting programs/courses related to the encouragement of the livelihood skills of the needy people at the skill center of the Donee.

DONEE

1. The Donee shall utilize all the amount of donation in Skill Development programmes/courses and shall endeavor to strengthen livelihood skills of the needy people by providing proper teaching, training and environment to excel in their respective fields.
2. The Donee may utilize the funds in procuring infrastructure that may be required for the operation of the Skill Development programmes/courses conducted by the Second Party.

5. SUPERVISION

- a. The Donor may oversee all the activities by making timely visits.





- b. The Donee will update the Donor by sending periodic development reports to the Donor so that they can see the utilization of their money at every step.

6. GENERAL

- a. This MoU can be modified, through a written document signed by duly authorized representatives of both parties.
- b. The MoU shall be executed in two counterparts and each copy to be deemed as an original.

7. INDEMNIFICATION

That the parties shall indemnify each other and hold each other harmless against any and all direct damages arising from any act or omission pertaining to their obligation under this Agreement.

8. DISPUTE RESOLUTION

- a. That any dispute and/or difference arising out of or relating to this MoU, including interpretation of its terms shall be resolved amicably through joint discussion by the authorized representatives of both the parties.
- b. The courts at Dehradun, Uttarakhand shall have jurisdiction in case of any dispute.

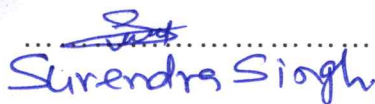

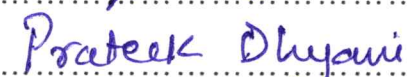
