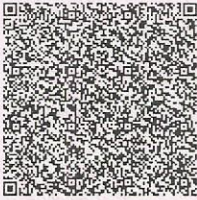

AGREEMENT

This agreement is made on September 15, 2023, between:

Party of the First Part: **Swami Rama Himalayan University, Dehradun** Registered Office at Swami Rama Himalayan University, Dehradun Hereinafter referred to as, which expression shall include its successors, permitted assigns.

AND

Party of the Second Part: **Gurman Medical Pvt. Ltd.** SCO 526 First Floor, TDI TAJ PLAZA SECTOR 118, Mohali, Punjab 140501. Hereinafter referred to as "Gurman Medical," which expression shall include its successors, assigns, and associate companies.

RECITAL:

- a) Swami Rama Himalayan University is engaged in providing healthcare services to patients, through its constituent unit Himalayan Hospital.
- b) Gurman Medical has ensured the presence of their technician through the night during the Sleep Study, performed at Himalayan Hospital. Next day Sleep data will also be analyzed and validated.
- c) Gurman Medical shall perform the interpretation of sleep study data, and provide the report within 24 hours.
- d) Data & analysis of sleep study done at Himalayan Hospital shall be sole property of SRHU.
- e) It will be liability of second party to repeat the test without any cost, if test is not performed in right way resulted in any error in test/result.
- f) Payment Amount: Swami Rama Himalayan University agrees to pay an amount of Rs. 3500/- (Indian Rupees) per Sleep Study test.
- g) Minimum Monthly Commitment: There is a minimum commitment set at Rs. 35,000/- per month. This means that Swami Rama Himalayan University commits to paying at least Rs. 35,000 per month for Sleep Study tests.
- h) Billing Exceeding Minimum Commitment: If the total billing for Sleep Study tests in a given month exceeds Rs. 35,000/-, then the higher value between the actual billing and the minimum commitment (Rs. 35,000/-) will be applicable and payable by Swami Rama Himalayan University. This ensures that if they use more Sleep Study tests than initially committed, they will pay for the actual usage.
- i) Gurman Medical shall submit a monthly invoice for the tests conducted during the previous month by the 1st of every month, and payment will be released by the hospital on or before the 10th of every month by mail.
- j) Termination: Notwithstanding the above, either party shall be entitled to terminate this agreement by giving one months' written notice to the other.
