## Notice for Admission into Postgraduate Super-Specialty (M.Ch./DM) Programmes, for Academic session 2025-26

It is hereby informed that for the academic session 2025-26, admissions to Post Graduate Super-speciality Programmes (M.Ch./DM) conducted at **Himalayan Institute of Medical Sciences**, a constituent academic unit of the Swami Rama Himalayan University, (an University Established under section 2(f) of UGC Act, 1956) shall be made on the basis of merit/rank of All India NEET Super Specialty-2025 (NEET-SS-2025) through common counselling, conducted at National Level by Medical Counselling Committee (MCC) of the Directorate General of Health Services (DGHS), New Delhi.

3. Tuition fee for first year must be deposited in full at the time of admission as above. However, fee in the second year and third year of the course may be deposited in two equal instalments.
