### Mode of Payment:

- 1) Candidates, who have been allotted the seat, are required to pay **Rs.50,000/- (Rupees Fifty Thousand Only)** to secure admission **on the day of counseling** failing which he/she shall have NO CLAIM whatsoever on the seat allotted through counseling.
- 2) Remaining amount of fees must be deposited within a week.
- 3) Fees can be deposited through bank demand draft drawn in favour of Swami Rama Himalayan University or through RTGS / NEFT directly to University Bank Account No. 33082676422, IFSC: SBIN0010580, State Bank of India, HIHT, Jolly Grant, Dehradun, Branch Code: 10580.

- 4) Admission Order can be obtained from Himalayan College of Nursing after submission of the fees mentioned in Allotment Order and physical verification of the documents from original documents.

**NOTE:**

- 1) Allotment of seats will be done strictly on merit basis prepared on the basis of marks obtained in last qualifying examination, subject to verification of original certificates/documents of the candidates. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding on the day of counseling as per the schedule.
- 2) All admissions are subject to fulfillment of eligibility conditions by the candidates. If it is found during physical verification or at a later stage, that the candidate has given false information / certificate or is found to have concealed some information, his/her admission is liable to be cancelled without any notice and the fee deposited shall not be refunded.
- 3) All allotments shall be subject to verification of the authenticity of the candidates' original certificates/documents prior to issuance of the Admission Order by Himalayan College of Nursing. The decision of the Admission Committee regarding the eligibility of any applicant shall be final and binding.
- 4) If the candidate leaves the program before 30<sup>th</sup> September 2026, the Admission Fees shall not be refunded. In case the candidate wants to discontinue the program after 30<sup>th</sup> September 2026 then he / she shall be required to deposit the fee for the entire duration of the program.
- 5) As per the directions issued by the Apex Court, the candidate may be required to furnish a bond or bank guarantee towards the balance fee payable for the remaining duration of the course in the event of the candidate leaving the course midstream.

Therefore, all candidates who obtain admission at Himalayan College of Nursing shall be required to submit at the time of joining, either a bank guarantee for the tuition fee of the entire duration of the course.

OR

Post-dated cheques in favour of Swami Rama Himalayan University towards the balance unpaid tuition fee for the remaining duration of the course, as security for payment.
