**Notice for Admission into undergraduate medical –
MBBS programme, Academic session : 2024-25**

1. It is hereby informed that for the academic session 2024-25, admissions to undergraduate medical-MBBS programme conducted at Himalayan Institute of Medical Sciences, a constituent academic unit of the Swami Rama Himalayan University, (a University Established under section 2(f) of UGC Act, 1956 shall only be made based on the merit of **NEET-UG-2024** through common counselling conducted by the State Government or its designated authority and none else.
2. The Himalayan Institute of Medical Sciences, has permission from National Medical Commission, formerly known as Medical Council of India, to admit 150 candidates in MBBS programme. As per the provisions of sub-section 1 of section 13 of the Uttarakhand Private Universities Act, 2023 (Uttarakhand Act no. 02 of 2024) 40% seats (i.e. 60 seats) are reserved for the permanent Residents of Uttarakhand. Reservation policy of the State of Uttarakhand shall be applicable on these 60 (Sixty) seats.
3. All **NEET-UG-2024** qualified candidates are invited to register for the process of common counselling & admission into **Himalayan Institute of Medical Sciences**. For registration process and other related details for common counseling, kindly visit the website www.hnbumu.ac.in.
4. Fee:
 - 4.1 As per the provisions of sub-section 2 of section 13 of the Uttarakhand Private Universities Act, 2023 (Uttarakhand Act no. 02 of 2024), 26% rebate in tuition fee shall be applicable to 60 candidates who are admitted under the State Quota having Permanent Resident of Uttarakhand certificate. The rebate shall be given as per the merit of the candidates after the last date of admission and on completion of the admission process.

4.4 **Note:**

- (i) The fees for First Professional shall continue to be charged till the candidate passes out the First Professional University Examination.
- (ii) The candidate must pass First Professional in 12 (twelve) months; otherwise tuition fees shall be charged as follows:
 - (a) If a student fails or is detained in 01 (one) subject in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay 1/3 (one-third) amount of the existing tuition fee per annum as additional tuition fee till the student passes out First Professional Examination.
 - (b) If a student fails or is detained in 02 (two) subjects in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay 2/3 (two-third) amount of the existing tuition fee per annum as additional tuition fee till the student passes out First Professional examination.

- (c) If a student fails or is detained in all the subjects in First Professional University Main Examination and does not pass supplementary examination, that is conducted immediately after the main University Examination, he/she shall pay full existing tuition fee as additional tuition fee per annum till the student passes out First Professional University Examination.
- (d) Under no circumstances the student shall be allowed more than four (04) attempts for first year (First Professional MBBS) and no student shall be allowed to continue undergraduate medical course after nine (09) years from the date of admission into the course.
- (iii) After passing the First Professional Examination, every student must pass Second Professional, Third Professional Part-I & Third Professional Part-II in 42 (forty-two) months. If he/she fails to do so, he/she shall pay $\frac{1}{2}$ (half) amount of the tuition fee determined by the University for Third Professional Part-II as an additional tuition fee per annum till he/she passes Third Professional Part - II University Examination.
- (iv) As per the orders passed by the Hon'ble Apex Court from time-to-time, the candidate is required to furnish either cash security or bank guarantee for the fee payable for the remaining period of the programme.

Therefore, all candidates who obtain admission at Himalayan Institute of Medical Sciences shall be required to submit at the time of joining, either a bank guarantee for the balance unpaid tuition fee

OR

Post-dated cheques in favour of Swami Rama Himalayan University for the balance unpaid tuition fee.

The bank guarantee/cheques will be encashed by the University in case the candidate leaves the programme midstream, after the last date of admission.
